RIGHT OF USE PERMIT

KNOW ALL MEN BY THESE PRESENT that on this ______ day of ______,20__ the City of Columbia, a municipal corporation, in consideration of the sum of ten dollars (\$10.00) and other considerations to it paid, does hereby permit **Veterans United Home Loan** their heirs and/or assigns (hereinafter referred to as "Permittee") to install or have installed private street signs within the public right of way on Forum Katy Parkway.

- 1. This permit is for the exclusive purpose of maintenance and placement of standard private street name signs in the public right of way on Forum Katy Parkway.
- 2. The purpose of the private street name signs shall be to identify the properties occupied by Veterans United Home Loan and located at 1400 Forum Boulevard (current address) as 1400 Veterans United Drive (new address, assigned by the Community Development Director with consent of the City Council).
- 3. Permittee will be responsible for the costs of any future repairs, maintenance or replacements which is the result from Permittee's use under this Right of Use Permit.
- 4. Signs shall be fabricated, installed and maintained by the City of Columbia Public Works Department. The permittee shall pay all installation and maintenance costs, including the cost of replacement as necessary.
- 5. Signs shall be a standard height, lettering, placement and design for street signs and shall read "Veterans United Drive" in black letters on a white background.
- 6. If the signs are abandoned, all rights herein granted shall cease and terminate and Permittee shall have no further right of interest therein except that, upon abandonment, Permittee remains responsible for all of the sign structures left in place and any costs to remove them or store them or to otherwise clean up the right of way.
- 7. If at any time construction, repair, modification or relocation of the signs or any utility existing in the right-of-way at the time this permit is granted, is necessary which would require the relocation of the sign or any of its components, the Permittee shall bear the expense of sign relocation.
- 8. The Permittee agrees by exercising its rights under this permit that if the sign or any of its components is damaged in anyway, whether negligently or intentionally by the construction, repair, modification or relocation of any utility existing in the right of way at the time this permit is granted it will repair or replace the sign at their own cost and hold the City of Columbia harmless for any of the costs associated with the repair or replacement or any other costs associated with the damage to the facilities.
- 9. This permit shall remain in effect until canceled by the City of Columbia, which shall be obligated to notify Permittee six (6) months in advance of the cancellation.

EXECUTIVE SUMMARY:

Veterans United Home Loan has informed staff that the company no longer wants to pursue the private street naming and address change at its Chapel Plaza Court locations. Instead, the company now requests a unique address along an internal roadway in the Forum Shopping Center. Attached for Council consideration is a new Council bill and right of use agreement.

DISCUSSION:

The naming of the internal roadway to Veterans United Drive and the associated address changes would only affect spaces leased and occupied by Veterans United. The company has the concurrence of the shopping center management.

The affected suite numbers are 17, 18, 48 and 49 and all have the address "1400 Forum Boulevard." The private roadway runs parallel to Forum therefore the building number should not be changed.

As before, the company would be responsible for private street signs. One private street sign would be necessary in public right of way, where the proposed Veterans United Drive intersects with Forum Katy Parkway, a City Street.

FISCAL IMPACT:

As before, fiscal impact is minimal, as Veterans United would bear the costs of installation and maintenance of the private sign in public right of way.




