- Request to extend service delivery period for Alternatives to Violence-AVP
 Workshops: Hollis said Alternatives to Violence had a difficult time getting the
 number of people needed for the workshops so they have requested additional time
 for the workshops. They believe the workshops will be complete by January. There
 was no objection to this request.
- Review of FY2009 Human Rights Enhancement RFP: The commission received a copy of the FY2008 RFP in their monthly mailing.

Thomas said he does have an issue with the applications focusing more so on multicultural programs rather than addressing actual human rights issues. He noted the RFP mentions multicultural education but reinforces the human rights emphasis throughout the proposal.

Hollis said there have been no changes made to the language of the RFP in recent years. Glaze noted there were a few years when the commission stressed multiculturalism.

Thomas suggested making changes to the RFP to steer more toward Human Rights. Paredes suggested in this change to include examples.

The commission will bring suggestions to the January meeting.

A. Community Services: Hollis said letters were sent to the organizations regarding preliminary funding recommendations. He spoke with Centro Latino about their proposal and possible revisions for next year. He also spoke with LGBT Coaltion about the changes the commission required of the proposal.

Hollis said almost all of the applications needed some form of correction. He has only received a few corrections this far.

The commission will present their funding recommendations to City Council on December 4.

Hollis said Ward worked with the LGBT Coalition to have special a showing of "Not in Our Town" last week. Attendance was low but staff will continue to work the LGBT Coalition to create more community dialogue about discrimination toward this protected class.

Ward is not at the meeting due to family issues.
