Council Bill No. B 266-12

AN ORDINANCE

amending Chapter 2 of the City Code to eliminate the Commission on Community Cooperation, the Career Awareness and Related Experience (C.A.R.E.) Advisory Board, the Internet Citizens Advisory Group, the Armory Board and the Special Business District Board; amending Chapter 10 of the City Code to eliminate the Public Communications Resource Advisory Committee; abolishing the GetAbout Columbia: Non-Motorized Transportation Pilot Project Advisory Committee; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 2 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended to eliminate the Commission on Community Cooperation, the Career Awareness and Related Experience (C.A.R.E.) Advisory Board, the Internet Citizens Advisory Group, the Armory Board and the Special Business District Board by repealing certain divisions or articles as follows:

1. Repeal Division 6 of Article V relating to the Commission on Community Cooperation.
2. Repeal Division 11 of Article V relating to the Career Awareness and Related Experience (C.A.R.E.) Advisory Board.
3. Repeal Division 12 of Article V relating to the Internet Citizens Advisory Group.
4. Repeal Article VI relating to the Armory Board.
5. Repeal Article IX relating to the Special Business District Board.

SECTION 2. Chapter 10 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended by repealing Article II relating to the Public Communications Resource Advisory Committee.

SECTION 3. The GetAbout Columbia: Non-Motorized Transportation Pilot Project Advisory Committee established on February 13, 2006 is hereby abolished.

SECTION 4. This ordinance shall be in full force and effect from and after its passage.

EXECUTIVE SUMMARY:

This legislation would eliminate the Armory Board, C.A.R.E. Advisory Board, Columbia Special Business District Board, Community Cooperation Board, GetAbout Columbia: Non-Motorized Transportation Pilot Project Advisory Committee, Internet Citizens Advisory Group, and Public Communications Resource Advisory Committee as directed by Council at the September 4, 2012 Council Meeting.

DISCUSSION:

A report with suggested changes to certain boards, commissions, committees and task forces was presented to Council at the September 4, 2012 Council Meeting. Included in the report was the recommendation to eliminate the Armory Board, C.A.R.E. Advisory Board, Columbia Special Business District Board, Community Cooperation Board, GetAbout Columbia: Non- Motorized Transportation Pilot Project Advisory Committee, Internet Citizens Advisory Group, and Public Communications Resource Advisory Committee. Council agreed and directed staff to prepare the appropriate legislation to eliminate these groups.

FISCAL IMPACT:

Unknown, but likely a savings in staff time in some situations.
