

Magnificent Murals

A unique feature and cultural resource of the Howard Building is a series of 12 murals adorning the walls of the Municipal Courtroom. Painted between 1934 and 1938 by then University of Missouri art professor Kenneth Hudson, the murals depict the history and development of the city of Columbia. Subjects and scenes include Native Americans; a wagon trail; the first Boone County Trial; the "Old Plank Road"; railroad, mining and agricultural industries; and a 1930s street scene of downtown Columbia. The murals were cleaned and restored this year as a component of the overall renovation of the Howard Building. Memorial Rededication Set for August 28

Columbia's Martin Luther King, Jr. Memorial will be rededicated on Monday, August 28 in a ceremony beginning at 6 p.m. The public is invited to attend and celebrate the reopening of the Memorial, one of two to Dr. King in Missouri and one of the largest in the nation.

The Memorial, located at 800 S. Stadium Boulevard at the MKT Trail entrance, was designed by artist Barbara Grygutis and was originally dedicated in 1993. Soon after its completion, an unsightly calcium carbonate crust began to develop on the blue tiles of the Memorial amphitheater because of water run-off problems.

A fundraising campaign led by the New Century Fund was held in 2003, raising more than \$83,000 for the restoration work and a maintenance endowment. Additional funds for the project came from the city and a \$98,000 Department of Interior Save America's Treasure's grant.

Restoration work on the Memorial appears to be successful and will provide long-term solutions to issues that have plagued the work over the years. In addition to new blue tiles, the Memorial's foundation has been reworked with a water-proofing system and two new drains were added to handle rainwater. A new brick walkway along the upper areas of the Memorial is being installed as well.

The park area surrounding the Memorial was renamed Battle Garden in August 2003 to honor community leaders Eliot and Muriel Battle. Improvements in those areas were also incorporated into the project, including construction of a small shelter, new walkways, interpretive information about King and Columbia's Memorial and a new sign along Stadium Boulevard.

Howard Building Renovations Completed

As renovations to the Howard Building, 601 East Broadway, were completed, the results of good planning and construction became evident. People who worked on the building, workers who set up furniture, and employees who moved into the building were, for the most part, very impressed with the way the construction turned out. On May 25 the Prosecutor and staff, along with Parking Enforcement, were the first to move in. The Municipal Court employees moved in on May 30th, and May 31 was the first day court was held in the refurbished Municipal Court.

Visitors to the renovated Howard Building will find offices for Human Resources and Employee Health located on the first floor, Prosecutor's offices and Municipal Court on the second floor, and Parking Enforcement and Building Maintenance in the basement.

Combining the old with the new has allowed for the building to keep its historical feel using modern construction and safety methods.

The projected cost for the Howard/Gentry renovations was \$1,766,047 for the Howard Building and \$767,620 for the Gentry Building for a combined cost of \$2,533,667. Committing the resources to remodel this building will allow the Howard Building to serve the community for many years to come. Work on the Gentry Building started June 1.

Council Action

The Council on May 1:

- Appropriated funds for street and sidewalk projects authorized by voters during the November 2005 election. The ordinance appropriates \$6,825,000 for the salt storage facility, Gans Road/U.S. 63 Interchange and various annual projects.
- Authorized an agreement with the Missouri Department of Health and Senior Services for the fiscal year 2006 Summer Food Service Program. The MDHSS contracts with the Columbia/Boone County Health Department to provide sanitation inspections. The contract period began May 15 and ends Sept. 15.

The Council on May 15:

- Authorized the Douglass Park Pool Improvement Project; called for bids; appropriated funds. Planned improvements include renovating the pool shell, plumbing and mechanical systems and possible minor improvements to the bath house at an estimated cost of \$299,000. The city's fiscal year 2006 budget included an appropriation of \$149,000, \$99,000 from Community Development Block Grant funds and \$50,000 from parks sales tax funds. An additional \$150,000 was included in the November ballot issue.
- Amended Chapter 26 of the City Code as it relates to taxation of telephone companies and telecommunications companies to conform with the Municipal Telecommunications Business License Tax Simplification Act, which will replace the seven percent gross receipts tax on telephone companies with a three percent gross receipts tax. This change is mandated by legislation passed by the Missouri General Assembly last year and is intended to be revenue neutral.



Columbia receives honorable mention citation...

... in the U.S. Conference of Mayors/Waste Management 2006 City Livability Awards Program

Mayor Darwin Hindman accepted an Honorable Mention Citation for the 2006 City Livability Awards that were presented June 3 during the Bike, Walk er WHEEL WEEK U.S. Conference of Mayors meeting in Las Vegas. The award made Columbia one of the top 10 cities recognized in the Livability Awards out of 250 cities that applied. The award is sponsored by the U.S. Conference



"I am delighted that the U.S. Conference of Mayors and Waste Management are recognizing the City of Columbia for its efforts in improving the quality of life for its residents," said Hindman. "Our citizens have good reason to be proud of Columbia and the

work that has been done to make their lives better. I am proud of the work being done as part of the annual Mayor's Challenge: Bike, Walk & Wheel Week which is the major reason for this award."

A press release issued by the U.S. Conference of Mayors praised Hindman as " . . . a champion of active living." His vision led to the implementation of Bike, Walk and Wheel Week in 2001, a campaign that challenges Columbians to leave their cars at home for a week and travel by human power. Bike, Walk Et Wheel Week is an energetic, week-long event to encourage residents to walk, cycle or wheel to work and other destinations to foster health, active living and safe transportation routes.

Bike, Walk and Wheel Week is a partnership between government, notfor-profit agencies and private businesses that coordinates 10 distinct events staffed by volunteers. The kick-off event includes a community bike ride or walk led by an honorary chair person. Activities include a bicycle recycling event, in which bicycles are donated to low-income residents, and a free breakfast at various locations throughout the city on "breakfast stations morning."

This year's event, lead by Judy Knudson, was highly successful and involved 80 sponsors, numerous volunteers, and had more than 2,450 participants.

Anyone who regularly runs, walks, or rides a bicycle on Columbia's trails has probably seen Volunteer of the Month Terry Barney along the trail.

Terry's Park Patrol duties include being a visible presence on the trails and providing a sense of safety for trail users. Patrollers alert Parks & Recreation of potential safety issues or trail maintenance needs. Terry, employed with the U.S.D.A. Natural Resources Conservation Service, has been part of the Park Patrol since its inception a decade ago and patrols city trails eight to 10 hours per week. "I like to give a little back to the city and the community at the same time," he says. A bicyclist as well as a runner, Terry finds his

time spent on the trails enjoyable. People are not always going to have someone in authority in the area when they are needed, Terry points out, and a Park Patroller often serves to discourage would-be troublemakers.

He says, "The most rewarding part of the job is meeting interesting people on Columbia's trails, everyone from senior citizens to members of the MU track team or cross-country team. It's a great way to have fun and stay healthy and do something constructive at the same time." Terry states, "You can't beat it!"

Peak electrical demand occurs during the hottest days of summer when electric consumption is critically high. In order for Water and Light to avoid purchasing additional electricity when wholesale electric prices are at their highest, the utility tries to reduce demand to keep rates low. If demand isn't reduced, it can add millions of dollars to Columbia's electric costs.

Please help your locally owned utility during Peak Warnings by delaying the use of major electric appliances in the afternoon.

- Set thermostats up one or two degrees
- Avoid heating the kitchen barbecue, use the microwave or prepare a cool meal
- Check and change the air conditioning/furnace filter

- Make sure all storm windows and fireplace dampers are closed
- Postpone until after 8 p.m.:

Water Saving Irrigation Tips

Do you need to water?

- Watering thoroughly, but infrequently, develops a deep root system so plants can use moisture and nutrients deep in the ground.
- Water according to moisture in the soil; not a fixed schedule.
- Lawns are dry when footprints remain in the grass long after being made.

How much should I water?

- Lawns need only one inch of water per week; approximately three times a week for 20 minutes.
- Use a tuna can or a rain gauge to accurately measure the amount of water your irrigation system or sprinkler delivers.
- Set a timer as a reminder to turn off the sprinkler.
- Water in the early morning from 6 a.m. to 8 a.m., avoiding windy conditions.

Other easy ways to conserve water outdoors:

- Don't irrigate the pavement; choose and adjust sprinklers to fit the lawn area.
- Mow grass to a height of 2 1/2 inches with a sharp blade.
- Never use a hose to rinse off pavement; sweep leaves and grass clippings.
