- 1. Under the provisions of Rule 37.49 (c) of the Supreme Court of Missouri relating to the practice and procedure in Municipal and Traffic Courts, the following offenses are designated within the authority of the Violations Clerk of the Court.
- 2. All offenses not listed and offenses which are listed below require a court appearance and may not be paid without an appearance in court:
- 3. Any violation resulting in personal injury or property damage.
- 4. Operating a motor vehicle while intoxicated or under the influence of intoxicants or drugs.
- 5. Operating a vehicle with a counterfeited, altered, suspended, or revoked license.
- 6. Fleeing or attempting to elude an officer.
- 7. Any other violation excluded by law.
- 8. Persons charged with careless and imprudent driving must appear in court.
- 9. Persons charged with a traffic violation involving an accident must appear in court.
- 10. Persons charged with parking violations filed with the court by the City Prosecutor must appear in court.
- 11. Court costs will be collected on all violations as indicated in accordance, except where indicated, with state and local laws:

- 14. The foregoing schedule of fines for offenses that may be paid out of court is hereby ordered to be in force and effect from and after the date of this order and to continue in effect unless sooner amended, supplemented or repealed by this court.
