AMENDMENT TO AGREEMENT

On this 12th day of December, 2013, the City of Columbia, Missouri (hereinafter referred to as the "City"), a constitutional charter city of the State of Missouri, and Community Foundation of Central Missouri, a nonprofit corporation of the State of Missouri, and Greater Horizons, a nonprofit corporation of the State of Missouri, (hereinafter referred to as the "Community Foundation") amend their agreement of September 4, 2012 as follows:

- 1. Paragraph 1 is amended to read as follows:
 - 1. City hereby establishes the Columbia Arts Fund Foundation ("Fund") with Greater Horizons ("Greater Horizons"), through its affiliate, the Community Foundation of Central Missouri. Once Community Foundation of Central Missouri becomes its own charitable tax-exempt entity, this Fund shall be a Fund of the Community Foundation of Central Missouri (Greater Horizons and the Community Foundation of Central Missouri shall collectively be referred to as the "Community Foundation").
- 2. All other provisions of the September 4, 2012 agreement shall remain in effect.
