

**AGREEMENT AND COVENANT NOT TO SUE AND PHOTO RELEASE (volunteer)**

I desire to participate, or have my son/daughter participate as a volunteer in the City of Columbia’s Parks and Recreation/Splat Jr. Obstacle Course Mud Run.

I am fully aware of risks and hazards connected with being on the premises and participating in the Event, and I am fully aware there may be risks and hazards unknown to me connected with being on the premises and participating in the Event, and I hereby elect to voluntarily participate or allow my child(ren) to participate in the Event, to enter upon Event premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including bumps, scrapes, strains, sprains, broken bones, head injury or death, that may be sustained by me and/or my child(ren) or any loss or damage to property owned by me, as a result of my being a participant in the Event, whether caused by the negligence of releases or otherwise.

In consideration for receiving permission to participate in the City of Columbia Parks and Recreation/Splat Jr. Obstacle Course Mud Run on Saturday, July 9, 2016, I hereby release, waive, and discharge the City of Columbia, MO, its officers, servants, agents and employees from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me or my child(ren), or to any property belonging to me while participating in the Event, or while in, on or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event.

It is my express intent that this Release shall bind the members of my family and my heirs, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue applicable to the above named releases. I understand that the City of Columbia frequently takes photos or videotape of people enjoying facilities and programs. These photos are for promotional and marketing materials. They are used at the city’s discretion and become its sole property.

I agree that I will obey the instructions and respect the staff and fellow participants. Whereas, having read and understood the above, I still desire to participate, or have my son or daughter participate in this obstacle course mud run, I agree to the terms set out herein.
