Department of Public Health and Human Services achieves accreditation

The Columbia/Boone County Department of Public Health and Human Services (PHHS) has achieved national accreditation through the Public Health Accreditation Board (PHAB). The national accreditation program works to improve and protect the health of the public by advancing and ultimately transforming the quality and performance of the nation's state, local, Tribal and territorial public health departments. PHHS is one of four local health agencies in the state of Missouri to have achieved national accreditation, and joins fewer than 200 of the approximately 3,000 health departments across the country to have achieved accreditation through PHAB since the organization launched in 2011.

The national accreditation program, jointly supported by the Centers for Disease Control and Prevention and the Robert Wood Johnson Foundation, sets standards against which the nation's nearly 3,000 governmental public health departments can continuously improve the quality of their services and performance. To receive accreditation, a health department must undergo a rigorous, multi-faceted, peer-reviewed assessment process to ensure it meets or exceeds a set of quality standards and measures.

Public health departments play a critical role in protecting and improving the health of people and communities. In cities, towns, and states across the nation, health departments provide a range of services aimed at promoting healthy behaviors; preventing diseases and injuries; ensuring access to safe food, water, clean air, and life-saving immunizations; and preparing for and responding to public health emergencies.

Strategic Plan – accreditation

A priority of the 2016-2019 Strategic Plan is to have City departments become accredited. The City has already celebrated the success of several departments in achieving that goal. Here are the departments that have achieved accreditation and which entity they are accredited through—

- Columbia Convention and Visitors Bureau was accredited in July 2015 by the Board of Directors for the Destination Marketing Accreditation Program
- Columbia Public Works Department, Community Development and Columbia Utilities were accredited in May 2016 by the American Public Works Association
- Columbia/Boone County Department of Public Health and Human Services was accredited in May 2016 by the Public Health Accreditation Board

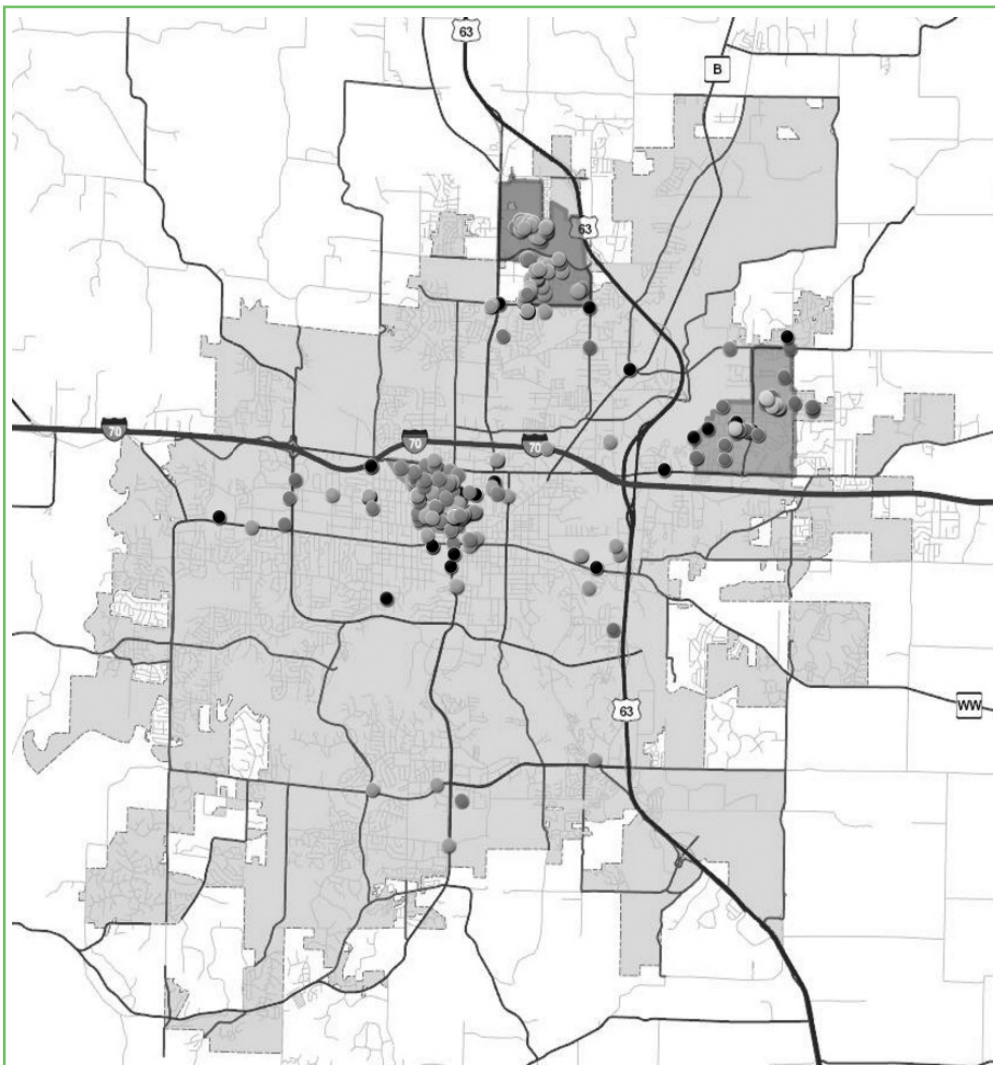

Connecting [with] cops

In March 2016 the Columbia Police Department's Community Outreach Unit (COU) was staffed with six officers and one sergeant. With two outreach officers stationed in each of the three Strategic Neighborhoods—Central, North and East—daily contacts were made with area residents. During the first three months of full formation, COU officers had interacted with nearly 1,100 residents in their strategic neighborhoods and nearly 500 residents outside of their strategic neighborhoods. Nearly 80 percent of these interactions were positive. Outreach officers have assisted individuals in setting up substance abuse treatment and mental health services, and built positive relationships through communication with citizens overall. The map below denotes where COU officers made contacts from April to June 2016.

Budget breakdown – budget public comment

City Council will hold a work session on Saturday, August 20 to discuss the proposed budget previously presented by City Manager Mike Matthes to City Council in July. This session is open to the public but the public cannot provide comment during the session. There will be three (3) scheduled sessions for the public to provide feedback on the proposed budget on August 15, September 6 and September 19. September 19 is also the date the City Council is scheduled to vote on adopting the budget for the coming fiscal year. The City encourages citizens to get involved with this process.

CPD renovations

Several building renovations are scheduled to begin soon for the Columbia Police Department (CPD). The renovations will include security upgrades, Americans with Disabilities Act (ADA) compliance improvements and renovation of building space and equipment replacement. The estimated cost for this project is \$795,000 and will be funded from CPD's Downtown Police Building Renovation Capital Improvement Project account.

The CPD headquarters was constructed in 1978 and was partially renovated in 1985, and again in the late 1990s. For several years, the building has housed Joint Communications. In April 2013 voters approved a three-eighths-cent sales tax to pay for a new building and operations for Joint Communications. They are expected to move out of the CPD building this fall and into an \$18 million Emergency Communication Center on Boone County Sheriff's Department campus at 2121 County Drive. This will open up Joint Communications' existing space at the police department and will be renovated to fit the needs of CPD.

City Council approved the renovations at the Council meeting on June 20. These improvements are separate from the North Municipal Center project that was approved by voters in August 2015. For more information on the renovations, visit CoMo.gov.

39th Annual Heritage Festival & Craft Show

History will come to life at the 39th Annual Heritage Festival & Craft Show at historic Nifong Park, 2900 E Nifong Blvd. Columbia Parks and Recreation will hold the festival from 10 a.m. to 5 p.m. on September 17 and 18. The Heritage Festival has no admission charge and offers entertainment and fun for all ages.

Visitors will experience living history by strolling through a replica Lewis and Clark outpost, cowboy camp and a lost arts area with traditional artisans. In addition, entertainers on three stages will be performing both days, including Festival favorites, the Haskell Indian Nations Dancers, along with a variety of traditional and roots music.

The Festival will also feature handmade crafts for sale, Fun for Young'uns Area with kids activities, hayrides, and tours of the Boone County Historical Museum, village and Maplewood Home. Ghost stories will be shared on the Maplewood Barn stage at 8 p.m. on Saturday, Sept. 17.

The Heritage Festival is coordinated by Columbia Parks and Recreation and sponsored by the Columbia Convention and Visitors Bureau, Columbia Daily Tribune, Boone County Historical Society, KFRU, KPLA 101.5, Missouri Life and the Missouri Arts Council.

Why are my summer utility bills high?

Columbia has not seen a prolonged, hot summer in a number of years. In June, temperatures were warmer and it was drier than we experienced for the last several years. This means that most customers have used more electricity so their air conditioner can combat the weather. Columbia Water & Light also saw a growth in water demand, mainly for irrigation, in June. Weather predictions for the rest of the summer are that the same weather pattern might continue due to La Niña.

New utility billing software

Utility Customer Service (UCS) is reaching the final stages of configuration and implementation for the new billing software. What that means is our "go live" date for the new software and billings statements will be within the next 90 days or less. Please keep in mind when the date is selected the UCS lobbies will be closed temporarily. UCS will make every effort to let customers know when those closures will occur. Letters will be mailed to customers around the time of the software conversion to explain all the detailed information that will be included in the new bills. Columbia Community Land Trust Initiative

The City of Columbia is considering the implementation of a community land trust (CLT) organization in Columbia. CLT's are community-based organizations whose missions include permanent stewardship of land for community benefit and perpetual preservation of the quality and affordability of housing on that land. The implementation of a CLT organization will enhance our community's ability to develop, protect and preserve long-term affordable housing in Columbia.

CLTs make it possible for limited income households to own homes on land that is leased from the CLT through long-term (typically 99-year), renewable ground leases. Each CLT homeowner receives deed and title to his or her home and leases the land on which the home sits from the CLT. In exchange for financial assistance which enables them to purchase a home they would not otherwise be able to afford, CLT homeowners agree to limit the price at which they can sell their homes, so the home remains affordable to additional limited income households without requiring the investment of additional public or private subsidies to make the home affordable again.

Implementing a CLT organization in Columbia will protect City investments in affordable homeownership opportunities the following ways—

1. Homes will resale to income qualified buyers at affordable rates.
2. Homes developed with public/private subsidies will remain owner-occupied.
3. Eliminates the need to provide additional subsidies to future buyers.
4. Homes will be managed to maintain their quality and condition.
5. Protects neighborhoods from adverse impacts of foreclosure.
6. On-going support will be provided to lower income homebuyers to ensure successful homeownership.

Conserve water this summer

When should I water my lawn?

- Water only if the soil needs it. Lawns are dry when footprints remain in the grass long after being made.
- Water in the early morning from 6 a.m. to 8 a.m., avoiding windy conditions.
- Water less frequently; this will help plants develop a deep, healthy root system.

How much should I water?

- Lawns need no more than 1 1/2 inches of water per week, including both irrigation and rainfall.
- Use a rain gauge found at a local hardware store to accurately measure your irrigation levels.
- If puddles or runoff start to develop, you have overwatered. Try setting a timer as a reminder to turn off the sprinkler system.

Easy ways to conserve water outdoors

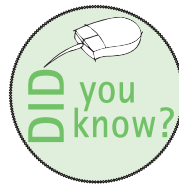
- Don't water your sidewalks and driveways. Adjust your sprinklers to cover only the lawn and plants.
- Mulch can help hold water and prevent weeds from growing.
- Leave grass a little longer to help prevent evaporation.
- Sweep leaves and grass cuttings rather than using a hose.

Sign Sweepers Volunteer Program

When you drive around Columbia you might notice signs that are placed in the median, taped to a utility pole or stop sign informing you about an upcoming sale or event. Did you know these signs are unlawful and can be removed?

A new volunteer program called Sign Sweepers has been started to proactively address these illegal signs. Volunteers are asked to spend a few hours each month removing unlawful signs from the City's right-of-way.

All signs collected are placed behind City Hall. We are looking for more volunteers to help in this effort. Multi-year Scott Boulevard Corridor project near completion

The Scott Boulevard Corridor, from West Boulevard to Route K, is currently on schedule to be completed by November or December 2016.

The Scott Boulevard Corridor project was designed to accommodate the rapid and continued growth in the west and southwest areas of Columbia. In 2009, the City explored the possibility of extending the Scott Boulevard Corridor to Interstate 70 and Route E just north of I-70. This phase of the project awaits federal and local funding.

The expansive project was divided into three major phases. In 2011, reconstruction and realignment of a portion of Scott Boulevard between West Broadway to just south of Gillespie Bridge Road, known as Phase I, was completed. Phase II, from Belleview Drive to Vawter School Road, was completed in August 2015.

The City is currently working to finish the final leg of Phase III, which was divided into three sections to minimize the length of road closures.

- Section one of Phase III, from Leighton Drive to State Route KK, was completed ahead of schedule on April 26, 2016.
- Section two, from just south of the Vawter School Road roundabout to just north of Sawgrass Drive and Stone Grove Court, is on schedule to be finished in August or September. This section included major reconstruction of Mill Creek Bridge to ensure the safety of heavy traffic anticipated on the bridge.
- Section three, from Stone Grove Court to Leighton Drive, is scheduled to be completed by November or December.

Once Phase III is finished, the funded Scott Boulevard Corridor projects will be complete. Updates on the projects are available at **ScottBv.com** and **CoMo.gov**.



Save with the window air conditioner exchange

(for income qualified customers)

- Have an older, less efficient and/or broken window unit to exchange
- Have an annual income of less than 200 percent of the poverty level
- Participants in 2015 are not eligible for the exchange this year

You must bring in the following items to participate:

- Proof of all income for everyone at your address (including food stamps and TANF)
- Current utility bill for your address
- An older, inefficient window air conditioner to exchange

Code Corner – sidewalk maintenance

As summer wears on, grass and vegetation creeps over sidewalks and into the right of way. Maintenance of the sidewalk in front of or adjacent to a property is the responsibility of the owner, operator, or person in control, such as a tenant. Sidewalk should be "clear and free from rubbish, filth, refuse, dirt, snow, ice and from any and all obstructions." Trees and tree limbs should also be cut back so they don't interfere with the passage of motor vehicles, bicycles or pedestrians using the right-of-way. Thanks for doing your part to keep sidewalks clear.

Keeping utility accounts current

During hot weather, it is especially important to keep current with utility bills. Per city ordinance found in Chapter 27-21 (h), the City of Columbia may shut off delinquent accounts when the temperature is above thirty-two (32) degrees Fahrenheit and below ninety (90) degrees Fahrenheit. Disconnections are based on actual temperatures, not forecasts, so when the actual temperature is below 90 degrees, services may be shut off. If your account is past due, please call 573-874-7380 or visit the Utility Customer Service office at 701 E. Broadway. If the account is eligible for a payment agreement, these are easily done.
