#### HISTORY OF THE FORMATION OF THE CITIZENS POLICE REVIEW BOARD

In 2007, a coalition of citizens and groups proposed the idea of creating a civilian review board to the City Council. The City Council appointed a fourteen member committee to study whether or not a review board was needed and to consider how such a board would be structured. The committee reviewed all complaints that existed before the professional standards unit was established. In addition, they studied and considered different models used by different cities, and hosted public events to gather input from the citizens. After extensive study and public input, the committee unanimously agreed to recommend that the City of Columbia establish a citizens police review board.

In July of 2009, the City Council of the City of Columbia, by adopting Ordinance No. 020331, created a nine member Citizens Police Review Board. The ordinance outlined the duties of the Citizens Police Review Board as follows:

The Citizens Police Review Board shall have the following duties:

- (1) Review appeals from the police chief's decisions on alleged police misconduct as provided for in this article.
- (2) Host public meetings and educational programs for Columbia residents and police officers.
- (3) Review and make recommendations to the police chief and city manager on police policies, procedures and training.
- (4) Prepare and submit to the city council annual reports that analyze citizen and police complaints including demographic data on complainants, complaint disposition, investigative findings and disciplinary actions. The reports should also describe the Board's community outreach and educational programs. The reports should also set forth any recommendations made on police policies, procedures and training. The reports shall be submitted no later than March 1 for the previous calendar year.

The City Council initially appointed the first eight members of the Citizens Police Review Board in November of 2009. Also in November of 2009, the Human Rights Commission appointed its first member to the Board. The Board met for the first time on November 18, 2009.

In 2014, the City Council, at the request of the Citizens Police Review Board, amended Section 21-49, to add additional duties. Pursuant to these amendments to the ordinance, the Board is also to conduct a jurisdictional review from the decision by the police chief that a person's allegations do not fall within the requirements set forth in the article related to complaints. The Board is also to conduct audits or reviews of the records of the police department for compliance with the requirements of the ordinances.

#### **EXECUTIVE SUMMARY**

This annual report includes information on the Citizens Police Review Board's work from January 2017 through the end of December 2017.

Pursuant to its mandate, the Citizens Police Review Board's accomplishments include:

- (1) The Board reviewed appeals from the police chief's decision on alleged police misconduct and conducted jurisdictional reviews of the police chief's decisions. During this reporting period, citizens requested that the Board review the police chief's decisions eleven (11) different times.
- (2) The Board hosted monthly public meetings with an opportunity for public comment at each regular monthly meeting, provided public educational programs on a variety of topics, and participated in community outreach.
- (3) The Board met with the police chief on two occasions (April 12, 2017 and December 13, 2017).
- (4) The Board is submitting to the City Council the following annual report which outlines the Board's actions from January 1, 2017 through December 31, 2017.
- (5) The Board has trained volunteer advocates available to assist complainants and police officers with the complaint and appeal process.
- (6) For the Board's mediation program, the City of Columbia has a contract with local attorney and mediator Lorri Kline to provide mediation services. During this review period, the Board referred one (1) case to mediation.
- (7) Darryl Smith attended the National Association for Civilian Oversight of Law Enforcement (NACOLE) national conference. Mr. Smith served as the City's voting member in the national organization.
- (8) In January 2017, Scott Dean and Andrew Fisher achieved the status of a Certified Practitioner of Oversight (CPO) through NACOLE. In September 2017, Darryl Smith achieved the status of a Certified Practitioner of Oversight (CPO) through NACOLE.
- (9) Four board members rode along with on duty police officers in 2017. Cornellia Williams completed a ride along with a police officer on May 12, 2017. Katelynn Towne completed a ride along on May 15, 2017. Baxter Nickels completed a ride along on May 30, 2017. Darryl Smith completed ride alongs on August 24, 2017 and on September 23, 2017.
- (10) The Board established a Strategic Planning Subcommittee in 2016. The subcommittee met on February 8, 2017. Recommendations made by the Strategic Planning Subcommittee, and approved with a majority vote by the

Citizens Police Review Board, were submitted to City Council for the March 6, 2017 council meeting.

#### SUMMARY OF APPEALS REVIEWED BY THE CITIZENS POLICE REVIEW BOARD

During this reporting period, the Board completed its review of two (2) appeals received in 2016 that were still pending and reviewed nine (9) new appeals filed in 2017.

The dispositions of the cases are summarized below.

#### <u>CPRB Case Number</u> Summary and Board's Action

2016-0009	A person filed an appeal on September 16, 2016. After its jurisdictional review on October 12, 2016, the Board unanimously voted that they had standing to review the appeal. After its initial review, the Board voted unanimously to affirm the Police Chief's decision for exonerating the officer on one allegation and further moved that the Board send back to the Police Chief for his reconsideration of his determination that another allegation did not fall within the guidelines of officer misconduct. Andrew Fisher, Scott Dean, Steve Sheltmire, Jayne Woods, Val DeBrunce, Darryl Smith, Renee Henson, Alan Meyer and James C. Martin voted in favor of the motion. As to the Police Chief's third finding, the Board voted unanimously to uphold the chief's decision with respect to the finding that the person complained of was not an employee of CPD. Andrew Fisher, Scott Dean, Steve Sheltmire, Jayne Woods, Val DeBrunce, Darryl Smith, Renee Henson, Alan Meyer and James C. Martin voted in favor of the motion.
	After its independent review of the remaining allegation on January 11, 2017, the Board unanimously voted to affirm the police chief's decision to exonerate the detective. Val DeBrunce, Andrew Fisher, Renee Henson, Alan Meyer, Steve Sheltmire, Darryl Smith, Jayne Woods, Cornellia Williams voted in favor of the motion.
2016-0011	A person filed an appeal on December 27, 2016. After its jurisdictional review on March 8, 2017, the Board

unanimously voted that they had standing to review the

appeal. After its initial review, the Board voted unanimously to sustain the Police Chief's decision on the complaint. Darryl Smith, Renee Henson, Steve Sheltmire, Andrew Fisher, Jayne Woods, Val DeBrunce, Scott Dean and Cornellia Williams voted in favor of the motion. The motion passed unanimously.

- A person filed an appeal on April 14, 2017. After its jurisdictional review on May 10, 2017, the Board unanimously voted that there was no jurisdiction because the complaint was not timely filed. Darryl Smith, Steve Sheltmire, Andrew Fisher, Val DeBrunce, Scott Dean, Alan Meyer, Cornellia Williams, and Katelynn Towne voted in favor of the motion. No one voted against the motion.
- A person filed an appeal on May 3, 2017. After its jurisdictional review on June 14, 2017, the Board unanimously voted that they had standing to review the appeal. The Board also unanimously voted that they had enough information to proceed. After its initial review, the Board voted unanimously to affirm the Police Chief's decision on the complaint. Val DeBrunce, Scott Dean, Alan Meyer, Baxter Nickels, Steve Sheltmire, Darryl Smith, Katelynn Towne, and Cornellia Williams voted in favor of the motion. No one voted against the motion.
- A person filed an appeal on May 3, 2017. After its jurisdictional review on June 14, 2017, the Board unanimously voted that they had jurisdiction to review the appeal and agreed with the Police Chief's decision on the complaint. Val DeBrunce, Scott Dean, Mr. Meyer, Baxter Nickels, Steve Sheltmire, Darryl Smith, Katelynn Towne, and Cornellia Williams voted in favor of the motion. No one voted against the motion.
- 2017-0004Two people filed an appeal regarding the same complaint on<br/>May 12, 2017. After its jurisdictional review on July 12, 2017,<br/>the Board unanimously voted that they had jurisdiction to<br/>review the appeal. After its initial review on July 12, 2017,<br/>the Board voted by majority to send this case to mediation.<br/>Val DeBrunce, Scott Dean, Andrew Fisher, Alan Meyer, Steve<br/>Sheltmire, Baxter Nickels, Katelynn Towne voted in favor of

the motion. Cornellia Williams voted against the motion. Darryl Smith abstained.

After a party declined mediation, the Board continued its review of the matter. On November 8, 2017, the Board voted by majority to affirm the police chief's decision on the complaint. Darryl Smith, Val DeBrunce, Stacye Smith, Bill Davis, Katelynn Towne, Baxter Nickels, and Cornellia Williams voted in favor of the motion. Andrew Fisher voted against the motion.

- A person filed an appeal on June 19, 2017. After its jurisdictional review on July 12, 2017, the Board unanimously voted that there was no jurisdiction because the complaint was not timely filed. Val DeBrunce, Scott Dean, Andrew Fisher, Alan Meyer, Baxter Nickels, Steve Sheltmire, Darryl Smith, Katelynn Towne, and Cornellia Williams voted in favor of the motion. No one voted against the motion.
- A person filed an appeal on June 28, 2017. On August 9, 2017. the Board voted by majority to approve the police chief's decision on the complaint. Val DeBrunce, Andrew Fisher, Baxter Nickels, Darryl Smith, and Cornellia Williams voted in favor of the motion. Scott Dean and Katelynn Towne voted no. Alan Meyer abstained.
- 2017-0007A person filed an appeal on July 6, 2017. On August 9, 2017,<br/>the Board unanimously voted that they had jurisdiction and<br/>to uphold the police chief's decision. Val DeBrunce, Scott<br/>Dean, Andrew Fisher, Baxter Nickels, Darryl Smith,<br/>Katelynn Towne, Alan Meyer, and Cornellia Williams voted<br/>in favor of the motion. No one voted against the motion.
- A person filed an appeal on July 20, 2017. On September 13, 2017, the Board unanimously voted that they had jurisdiction to hear the appeal and agreed with the Police Chief's decision on the complaint. Val DeBrunce, Scott Dean, Andrew Fisher, Katelynn Towne, Alan Meyer, and Steve Sheltmire voted in favor of the motion. No one voted against the motion.

A person filed an appeal on August 15, 2017. After its jurisdictional review on September 13, 2017, the Board unanimously voted that there was no jurisdiction because the complaint was not timely filed. Val DeBrunce, Scott Dean, Andrew Fisher, Katelynn Towne, Alan Meyer, and Steve Sheltmire voted in favor of the motion. No one voted against the motion.
