

Did you receive your bag vouchers?

Each January, curbside customers receive vouchers which are redeemable for recycling and trash bags. To receive bags free of charge, take your voucher(s) to a partnering retail store (full list at CoMo.gov), pick up bags from the shelf and present the voucher(s) at checkout. Street Talk: Pothole patching process heating up



Pavement expands and contracts during extreme hot and cold spells. This leads to potholes. The City of Columbia Street Division is now using an Asphalt Recycler to make a hot mix for repairing potholes on city streets throughout the year. A Hotbox trailer is then used to transport the mix to the street while keeping it a steamy 350 degrees all day.

Hot mix can be used any time of year as long as the street is relatively dry and free of snow. It's also more effective and reduces the cost of pothole repair by up to 40 percent. Once a pothole has been spotted or reported, it's the goal of

Public Works to repair it as soon as possible, within 24 to 48 hours, weather permitting. If you see a pothole, please report it by calling the City of Columbia Contact Center at 573.874.CITY (2489).

Did you know: Fair Chance Hiring Law

Did you know that the City of Columbia has the Fair Chance Hiring Law? Inspired by the national "Ban the Box" movement, this legislation removes questions about a job applicant's criminal record from applications and pushes questions about an applicant's criminal history until later in the hiring process.

How does it work in Columbia?

The City of Columbia Council passed a "Fair Chance Hiring Law" on December 1, 2014. The City of Columbia's ordinance applies to all employers within the city limits of Columbia and was effective after the date of passage. The legislation prohibits employers from having questions about an applicant's criminal history on a job application, and from inquiring about an applicant's criminal history, such as a background check, until after a conditional job offer. A conditional job offer means that employment is contingent upon the results of a criminal background check, much in the same way that a drug test works. The legislation does encourage employers to consider the nature of an offense, time passed since the offense, and actions taken after the offense to be considered for applicants found to have a record.

Why was it passed?

The implementation of "Fair Chance" legislation was one of the recommendations from the Mayor's Task Force on Community Violence, which was charged with bringing forward recommendations to reduce violence in Columbia. The legislation creates a fairer employment process for returning offenders. Questions about criminal history can be a deterrent for applicants with a record, and can be used to easily screen out ex-offenders before their other qualifications are considered. Full-time employment is the best predictor for reducing the chance that an ex-offender will reoffend. There are numerous benefits for lowering recidivism rates and getting ex-offenders back into society with gainful full-time employment.

When can an employer ask about an applicant's criminal record?

Employers are not prohibited from running a background check and they are not required to hire ex-offenders. The legislation requires that inquiries into an applicant's criminal history take place with a conditional job offer after all other qualifications have been considered.

Registration open for Molly's Miles

On Saturday, April 13, families, friends, co-workers, and supporters of law enforcement officers will gather together at the Molly Bowden Memorial Park, 900 W. Nifong Blvd., to walk and run in memory of those who have died in the line of duty and to honor their surviving families.

Molly's Miles is a family-friendly walk/run in its third year. Molly's Miles is named after Columbia Police Officer Molly Bowden who was shot and killed in the line of duty in 2005. All proceeds from the event benefit the Missouri Chapter of Concerns of Police Survivors (C.O.P.S.). The event includes a 5K, 10K, as well as a Virtual Run option for those who are unable to attend in person.

Registration for the 5K is \$30 for adults and \$30 for kids (12 & under) or \$100.00 for the family 4-pack. Registration for the 10K is \$35 for adults. Registration for the Virtual Run is \$20. City of Columbia, Voluntary Action Center partner on bus pass program

The City of Columbia, Go COMO and the Voluntary Action Center (VAC) have partnered to distribute free bus passes to income-eligible individuals in our community. The annual bus pass allows a rider unlimited access to the fixed route buses for 2019 without having to pay a fare.

This continued program is intended to improve access to reliable transportation for low-income residents and to better connect the community in a manner consistent with the City's Strategic Plan. Bus passes are limited. Non-profits may apply to receive small batch passes for clients, and individuals may apply for one pass per family member by submitting a brief application.

Progress as Promised: Sidewalk on Clark Lane complete

A newly completed sidewalk on Clark Lane and a new signalized crosswalk at the Highway 63 Connector greatly improves safety for pedestrians and nonmotorized transportation users along these busy roads.

The sidewalk was constructed along the north side of Clark Lane from Paris Road to Lambeth Drive. The signalized crosswalk was installed at the intersection of Clark Lane and the Highway 63 Connector.

The project was approved by City Council on Sept. 8, 2015 through the City's public involvement process. The contractor for the project was S&A Equipment & Builders. The \$1.03 million project investment was funded by a nonmotorized transportation grant from the Federal Highway Administration.

Smoke alarm safety

Smoke alarms save lives, and can cut the risk of dying in a fire in half. However, smoke alarms must be installed, maintained and working properly to do so. The Columbia Fire Department offers the following tips to stay safe:

Installation

- At least one smoke alarm should be located on every level of the home, including the basement, as well as in every sleeping room and outside each sleeping area.
- The National Fire Protection Association strongly recommends either installing combination smoke alarms, or both ionization and photoelectric alarms, in the home. An ionization alarm is typically more responsive to a flaming fire, such as a pan fire. A photoelectric alarm is typically more responsive to a smoldering fire, as might occur where a lighted cigarette is dropped on a sofa. Combination smoke alarms have ionization and photoelectric capabilities.
- Whatever type of smoke alarms you choose, they should carry the label of a recognized testing laboratory.
- Interconnected smoke alarms offer the best protection; when one sounds, they all do. This is particularly important in larger or multi-story homes, where the sound from distant smoke alarms may be reduced to the point that it may not be loud enough to provide proper warning, especially for sleeping individuals.
- A licensed electrician can install either hard-wired multiple-station alarms or wireless alarms, which manufacturers have more recently begun producing. An electrician can also replace existing hard-wired smoke alarms with wireless interconnection capabilities.

Maintenance and Testing

- Test smoke alarms at least once a month using the test button, and make sure everyone in your home knows their sound.
- If an alarm "chirps," warning the battery is low, replace the battery right away.
- Replace all smoke alarms, including alarms that use 10-year batteries and hard-wired alarms, when they're 10 years old (or sooner) if they do not respond properly when tested.

CARE summer applications close Feb. 28, work site partners needed

Applications for the City of Columbia's Career Awareness Related Experience (CARE) summer youth program will close on Thursday, Feb. 28. The summer program will take place this year from June 2 through July 24.

The CARE program hires at-risk 14- to 20-year-olds who live in the city of Columbia and/or attend a Columbia school. Youth go through a job interview process and are placed at local businesses where they gain real-world hands-on work experience while getting paid. CARE depends on partnerships with businesses and agencies to make the program successful. All of the trainees' wages are paid by the City of Columbia through the Parks and Recreation Department. There is no financial cost to the work site partners.

Consider signing up for budget billing

Are you interested in new ways to manage utility bills? March is enrollment month for the budget billing program. Budget billing allows customers to pay the same amount for their utilities each month whether the actual usage amount is lower or higher. The monthly budget billing amount is determined by using the last 12 months of bills and dividing the total by 11.

Current budget billing customers will receive their settle up statements in March, and their program participation will automatically renew as long as they continue to meet the program requirements. They will receive their new budget billing monthly amount on the April statement.


To qualify for budget billing, customers must have a full 12-month history at the current address and be current on their payments. Climate Action and Adaptation Plan update

In order to reach our emission reduction goals adopted by City Council in August 2018, City staff and members of the Mayor's Task Force for Climate Action and Adaptation Planning have been working hard to review and evaluate hundreds of potential actions.

Once determined, this initial list of actions will help Columbia reduce both community and municipal emissions in a variety of ways and help us prepare for a changing climate. Actions will address the areas of energy, housing, transportation, waste, natural resources, and health and may include incentives, policies or changes to current practices.

This past November, the City hosted a community forum at City Hall to gather feedback from the public and discuss the actions being considered for the Climate Action and Adaptation Plan (CAAP). We were thrilled with the turnout - over 200 people - and are grateful for the enthusiasm and feedback we've received so far. Your feedback will continue to be considered as we develop the plan, which is anticipated to be finalized this summer.

Code Corner: Carbon monoxide detectors

Carbon monoxide (CO) detectors are another tool for life safety. CO is an odorless, colorless gas that can kill. Starting with the adoption of the 2012 International Fire Code, the City has required all rental properties to have carbon monoxide detectors in housing units that have fuel-burning appliances or attached garages. Installation of CO alarms is advised for owner-occupied homes as well. They are inexpensive and easy to install.
