Operations Report

Significant Events from Operational Period:

- Picked up and delivered meals on wheels to individuals who are in isolation/quarantine in a hotel.
- Delivered formula and diapers to a family in isolation/quarantine.
- Secured appropriate lodging for individuals in isolation/quarantine unable to isolate/quarantine with their own resources.
- Delivered groceries to a case in quarantine unable to provide for themselves.
- Provided Volunteer hours from COVID response to city for capture of volunteer hours given to the city.
- Provided interview to KBIA
- Shared isolation video via social media to reach individuals who are in isolation who hasn't been reached yet.
- Reviewed 3 commercial COVID safety plans.
- Prepared and shared among staff a chart that shows a spike in cases that started in the end of June.
- Provided an interview to KRCG regarding recent Thanksgiving guidance.
- Provided an interview to KMIZ regarding increase in cases
- Provided two interviews to Columbia Tribune, regarding services for individuals experiencing homelessness who need to isolate/quarantine, and the recent surge in cases.
- Answered questions from The Missourian about the change in the infohub.
- PHHS and local hospitals had a communication coordination meeting.
- Interviewed a Public Health Educator for position to be funded with CARES Act funding to assist with COVID 19 response work.
- Extended conditional offer for a CARES Act funded Health Educator position.
- Environmental Health responded to and assigned staff to city/county complaints and inquiries.
- Continued case and contact investigations.

COVID 19 has reached global transmission.

- All 50 states, The District of Columbia, Puerto Rico, Guam, the Northern Mariana Islands, and the US Virgin Islands have reported cases of COVID-19.

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

More than half of the states in the United States have issued state wide mask mandates.

The CDC has updated guidance to change when isolation should end for a positive case of COVID 19, now reflecting one day free of fever and an improvement in symptoms. Isolation should end 10 days after symptoms have started. Links for this updated guidance can be found:

State Information:

Missouri Governor Parson declared a State Emergency on March 13, 2020 to make state resources available to local jurisdictions and activate certain authorities.

- A total 205,066 confirmed cases in Missouri of individuals who have been diagnosed with COVID 19, 3,150 of those cases have died.

City/County Information:

On March 16, 2020 the City of Columbia declared a state of emergency within the city to respond to COVID-19. The resolution includes calling for proactive measures to protect the public health, safety and welfare; expressing support for and calling upon City Manager John Glascock and Public Health and Human Services Director Stephanie Browning to enact regulations to protect the public health, safety and welfare.

As ESF-6 lead, City of Columbia Division of Human Services has activated a COVID-19 Get Help webpage website to list key human services resources needed during the pandemic: COVID-19 Get Help (<https://www.como.gov/health/gethelp-coronavirus/>).

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<http://comohelps.org>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

The University of Missouri hosts a walk up clinic for COVID 19 testing to its MU Students beginning 8/24/2020.

MU Healthcare hosts a drive thru COVID 19 testing site located at 115 Business Loop 70 W. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.
