## **Operations Report**

### Significant Events from Operational Period:

- Recorded highest number of new cases for Boone County.
- PHHS staff attended a call with DHSS regarding potential state recommendations based on CDC guidance regarding change in quarantine period.
- PHHS corresponding with other city departments on managing overnight accommodations during the winter for the homeless population during COVID 19.
- PHHS staff participated in NACCHO call regarding messaging and communication with people who have reservations about the science of the pandemic.
- Medical Director prepared email with recommendations for quarantining after reviewing CDC updated information and consulting with peers.
- Scheduled an information sharing call for health and medical emergency preparedness partners regarding COVID 19 vaccine distribution.
- PHHS leadership met with Boone County hospitals.
- PHHS staff attended a webinar for COVID 19 vaccinators hosted by DHSS.
- Corresponded with freezer companies to get estimation on delivery dates.
- Obtained additional zoom license for staff responding to COVID 19.
- Provided PHHS leadership with additional pay cost report from COVID 19.
- Researched to prepare for vaccination campaign.
- Worked with prosecutor's office to outline NOV process for county.
- Reviewed operational plans from businesses.
- Reached out to businesses to provide technical assistance in COVID 19 mitigation efforts.
- Reviewed plans for winter sport activities.
- Responded to emails relating to various topics of COVID 19.
- Environmental Health responded to and assigned staff to city/county complaints and inquiries.
- Continued case and contact investigations.

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

More than half of the states in the United States have issued state wide mask mandates.

The CDC has updated guidance to change when isolation should end for a positive case of COVID 19, now reflecting one day free of fever and an improvement in symptoms. Isolation should end 10 days after symptoms have started. Links for this updated guidance can be found:

### **State Information:**

Missouri Governor Parson declared a State Emergency on March 13, 2020 to make state resources available to local jurisdictions and activate certain authorities. On November 19, 2020 the State of Emergency was extended until March 2021.

### **City/County Information:**

On March 16, 2020 the City of Columbia declared a state of emergency within the city to respond to COVID-19. The resolution includes calling for proactive measures to protect the public health, safety and welfare; expressing support for and calling upon City Manager John Glascock and Public Health and Human Services Director Stephanie Browning to enact regulations to protect the public health, safety and welfare.

As ESF-6 lead, City of Columbia Division of Human Services has activated a COVID-19 Get Help webpage website to list key human services resources needed during the pandemic: COVID-19 Get Help (<https://www.como.gov/health/gethelp-coronavirus/>).

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<http://comohelps.org>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

The University of Missouri hosts a walk up clinic for COVID 19 testing to its MU Students beginning 8/24/2020.

MU Healthcare hosts a drive thru COVID 19 testing site located at 115 Business Loop 70 W. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.
