Operations Report

Significant Events from Operational Period:

- Received approval for County CARES Act funds amendment to the City contract.

- PHHS leadership met with other Missouri metro Local Public Health leadership regarding vaccine messaging.
- PHHS reached out to Landmark Hospital to ensure communication they were being included in hospital communication.
- Hosted faith leader town hall for COVID 19 information in worship and missions settings.
- Hosted a hospital and public health communications call for cohesive vaccine messaging.
- Provided an interview to KRCG and Columbia Tribune regarding vaccine and increase in deaths.
- PHHS staff attended webinar on national strategy for COVID 19 vaccination communication.
- Communicated with National Guard regarding PPE supplies that will be available for PHHS staff after their COVID testing mission is completed.
- Created a tool to capture isolation notification and education mailing that is sent back by post office.
- Received COVID 19 testing referral.
- Posted information regarding recent Boone County deaths from COVID 19.
- Reviewed business plans.
- Called businesses to provide education and technical assistance.
- Responded to various emails on a variety of COVID 19 topics.
- Reviewed operational plans for sports.
- Responded to questions regarding new quarantine guidelines from schools.
- Environmental Health responded to and assigned staff to city/county complaints and inquiries.
- Continued case and contact investigations.

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

More than half of the states in the United States have issued state wide mask mandates.

The CDC has updated guidance to change when isolation should end for a positive case of COVID 19, now reflecting one day free of fever and an improvement in symptoms. Isolation should end 10 days after symptoms have started. Links for this updated guidance can be found:

State Information:

Missouri Governor Parson declared a State Emergency on March 13, 2020 to make state resources available to local jurisdictions and activate certain authorities. On November 19, 2020 the State of Emergency was extended until March 2021.

City/County Information:

On March 16, 2020 the City of Columbia declared a state of emergency within the city to respond to COVID-19. The resolution includes calling for proactive measures to protect the public health, safety and welfare; expressing support for and calling upon City Manager John Glascock and Public Health and Human Services Director Stephanie Browning to enact regulations to protect the public health, safety and welfare.

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<http://comohelps.org>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

The University of Missouri hosts a walk up clinic for COVID 19 testing to its MU Students beginning 8/24/2020.

MU Healthcare hosts a drive thru COVID 19 testing site located at 115 Business Loop 70 W. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.
