

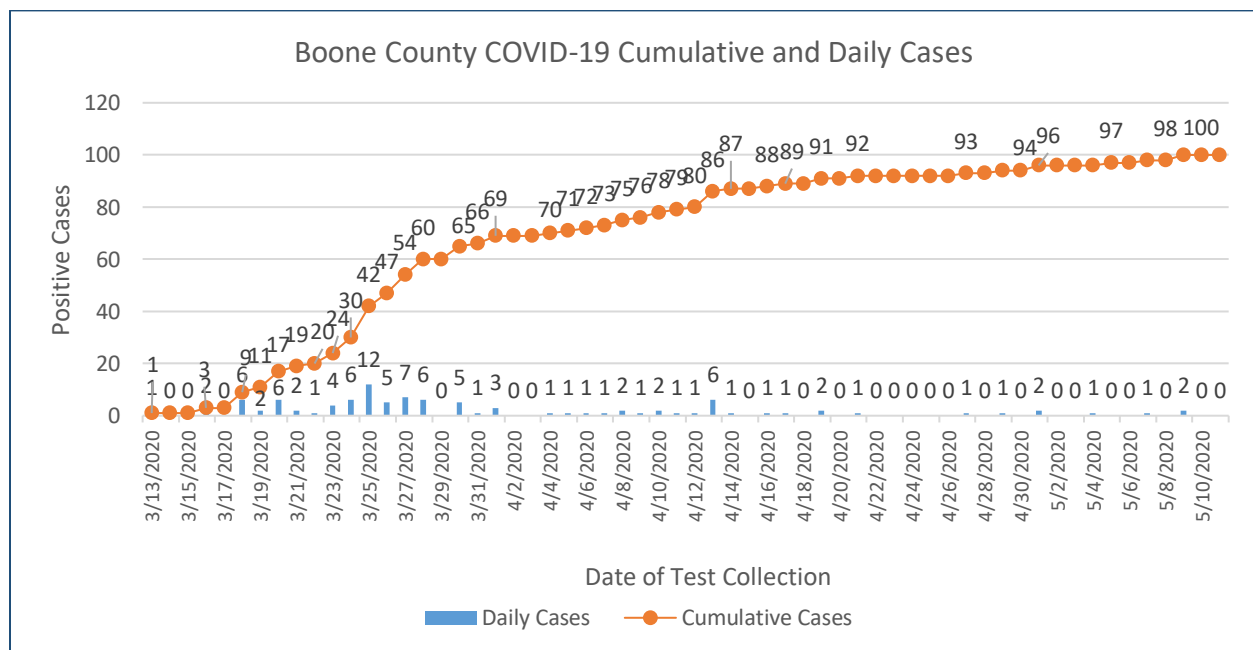

Incident Definition: Response to emerging Novel Corona Virus, now known as COVID-19. This includes-

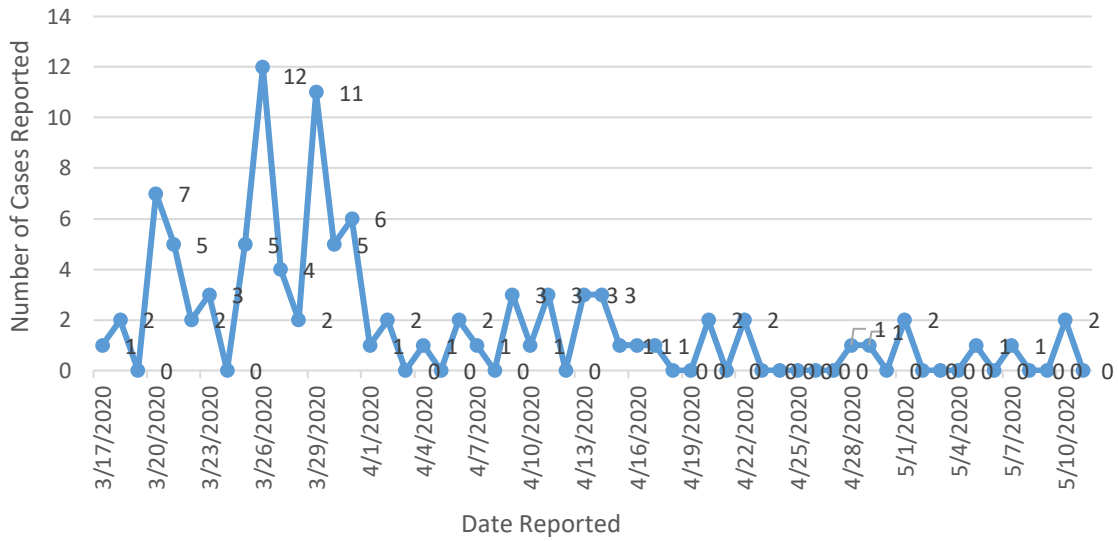
- Addressing general public concerns regarding COVID-19

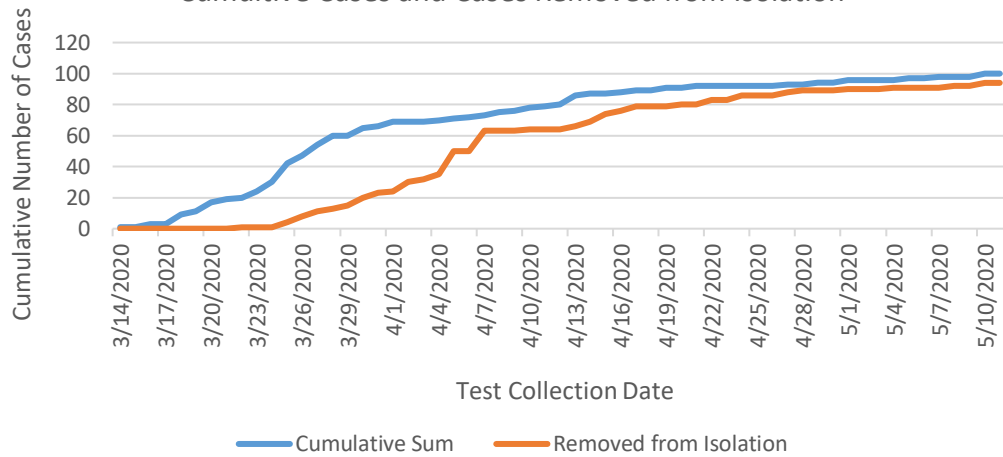

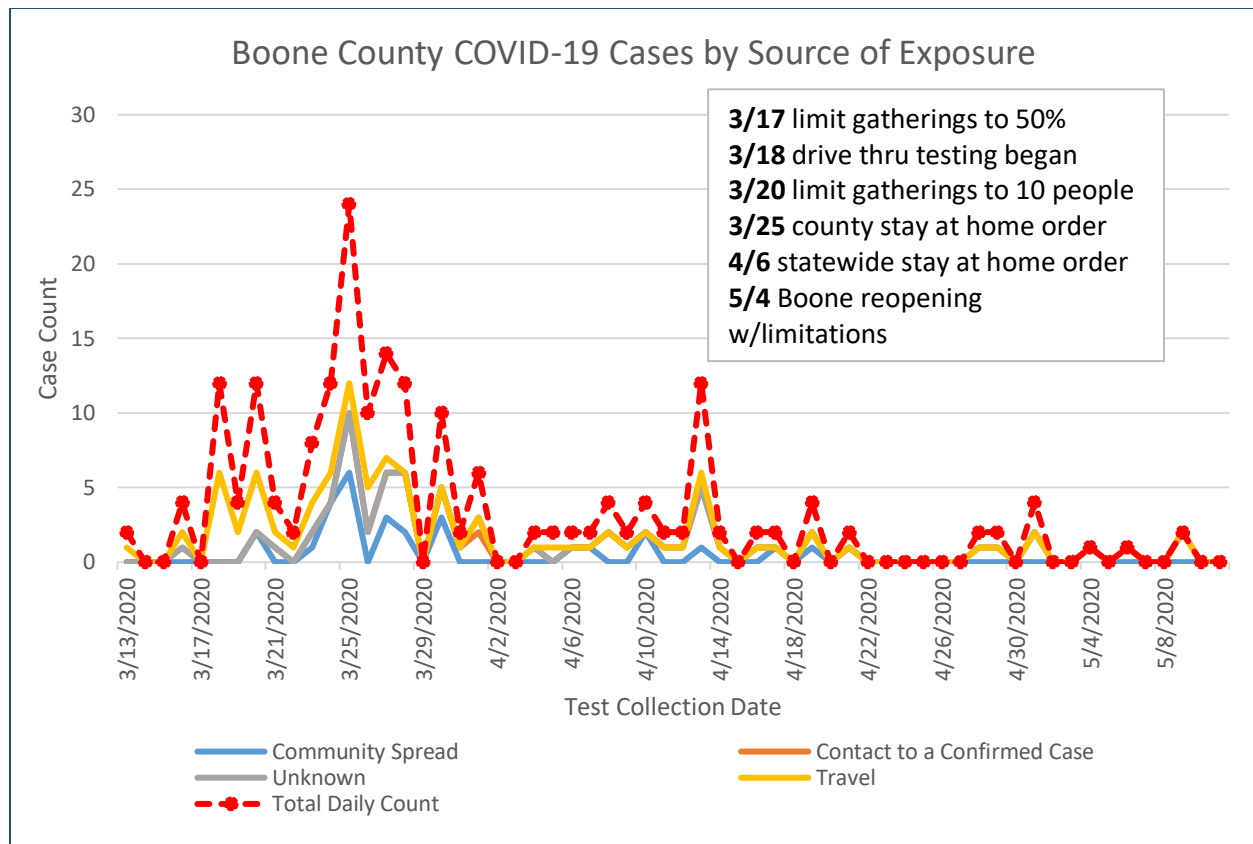


COVID-19 Cases by Report Date

Operations Report

Significant Events from Operational Period:

- Met with Springfield/Greene County Epi and Disease Containment Unit.
- Hosted remote testing today.
- Hosted Facebook live presentation of Contact Tracing process.
- Submitted expense tracker for COVID expenses from PHHS and submitted to finance.
- Placed remote testing banners in frames.
- Worked with project management office on a web based system to monitor contacts in quarantine.
- Participated in webinar regarding COVID 19 hosted by ECHO (Extension for Community Health Outcomes).
- Built spreadsheet for temporary cell phone allowances to accommodate staff working remotely and using cellular phones for work purposes.
- Scheduled upcoming remote testing times and sites.
- Fielded public, business and media inquiries.
- Continued case and contact investigations.

Situation Summary:

COVID 19 has reached global transmission.

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

The CDC has updated guidance to change when isolation should end for a positive case of COVID 19. Isolation should end 10 days after symptoms have started. Links for this updated guidance can be found:

At Risk Population: Older Adults (60 years of age or older), People who live in a nursing home or long-term care facility, and People with Chronic Health Conditions (Heart Disease, Lung Disease or Asthma, Diabetes, People who are immunocompromised including cancer treatment, or people who are severely obese)

State Information:

Missouri Governor Parson declared a State Emergency on March 13, 2020 to make state resources available to local jurisdictions and activate certain authorities.

- A total 9,918 confirmed cases in Missouri of individuals who have been diagnosed with COVID 19, 488 of those cases have died.

City/County Information:

On March 16, 2020 the City of Columbia declared a state of emergency within the city to respond to COVID-19. The resolution includes calling for proactive measures to protect the public health, safety and welfare; expressing support for and calling upon City Manager John Glascock and Public Health and Human Services Director Stephanie Browning to enact regulations to protect the public health, safety and welfare.

- There are 100 confirmed cases in Boone County, a patient passed away on 3/18/2020, and 63 have recovered from the COVID 19 illness.

Columbia and Boone County issued Public Health Orders for Social Distancing to begin on May 4 and continue until another Public Health Order is issued, they can be found at:

Boone County Office of Emergency Management opened a virtual EOC on 3/17/2020 to facilitate the coordination of efforts and resources to keep Boone County safe during COVID-19 response efforts.

As ESF-6 lead, City of Columbia Division of Human Services has activated a COVID-19 Get Help webpage website to list key human services resources needed during the pandemic: COVID-19 Get Help (<https://www.como.gov/health/gethelp-coronavirus/>).

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<http://comohelps.org>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

MU Healthcare hosts a drive thru COVID 19 testing site. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.

Daniel Boone Regional Library will remain closed through Mid-May and has cancelled all May library events.
