### **Operations Report**

#### Significant Events from Operational Period:

- Attended meeting with hotel operators today to answer questions and address concerns from that part of commerce in our community.
- Participated in conversation with hospitals about their operations moving forward regarding visitor access to hospital and social distancing.
- Met with partners participating in remote outreach for COVID 19 testing discussing participation in future events.
- Met with a nurse from the Columbia Public Schools about the guidance and guidelines that was provided by
  DESE and Missouri School Board Association regarding PPE needs for school nurses, assistance in contact tracing,
  and how to manage if an individual in the school system is a positive COVID case.
- Provided website updates to accurately describe operation capabilities of each PHHS division.
- Visited a property to determine if it would meet the needs of a Quarantine and Isolation resource.
- Updated Business Guidance to include a section to assist social service delivery agencies with information and clarification.
- Gathered documents to respond to record requests.

- Fielded public, business and media inquiries.
- Continued case and contact investigations.

### **Situation Summary**:

COVID 19 has reached global transmission.

- All 50 states, The District of Columbia, Puerto Rico, Guam, the Northern Mariana Islands, and the US Virgin Islands have reported cases of COVID-19.
- 35 state and 1 territory report COVID-19 cases are "widespread; 28 state report more than 10,000 cases of COVID-19

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

Missouri Governor Parson declared a State Emergency on March 13, 2020 to make state resources available to local jurisdictions and activate certain authorities.

# **City/County Information:**

On March 16, 2020 the City of Columbia declared a state of emergency within the city to respond to COVID-19. The resolution includes calling for proactive measures to protect the public health, safety and welfare; expressing support for and calling upon City Manager John Glascock and Public Health and Human Services Director Stephanie Browning to enact regulations to protect the public health, safety and welfare.

• There are 100 confirmed cases in Boone County, a patient passed away on 3/18/2020, and 94 have recovered from the COVID 19 illness.

Columbia and Boone County issued Public Health Orders for Social Distancing to begin on May 4 and continue until another Public Health Order is issued, they can be found at:

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<a href="http://comohelps.org">http://comohelps.org</a>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

MU Healthcare hosts a drive thru COVID 19 testing site. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.

Daniel Boone Regional Library will remain closed through Mid-May and has cancelled all May library events.
