### **Operations Report**

Significant Events from Operational Period:

- Presented during the Community COVID 19 Meeting.
- Shared information that Columbia Public Schools has moved their start date back to after Labor Day.
- Began sharing rolling case number per 10,000 of 7 day average.
- Information and Guidance staff met with MU Incident Command staff about communication and coordination of PHHS for off campus students.
- Followed up on complaints regarding non-compliance with mask ordinance in local establishments.
- Provided an interview to Columbia Missourian regarding non-compliance reports for mask ordinance.
- Visited local establishments that requested inspection to ensure appropriate measures were in place for social distancing in line with new Public Health Order.
- PHHS leadership met with County Commissioners.
- Participated in state's tabletop exercise rehearsal.
- Obtained additional zoom licenses for Zoom to assist the Epi/Disease Containment unit.
- Corresponded with City Legal department regarding ELC Cares Contract changes.
- Responded/assigned staff to City/County complaints.
- Provided clarification to hotels regarding new order.
- Environmental Health and Information and Guidance worked together to respond to complaints and inquiries from businesses.
- Updated prior case data into online case investigation management tool.
- Responded to public and media inquiries.
- Continued case and contact investigations.

### Situation Summary:

COVID 19 has reached global transmission.

CDC has begun recommending all individuals wear facemasks to reduce the chance of transmission while out in public as of 4/3/2020. Children under the age of 2 should not wear masks because of suffocation risk.

More than half of the states in the United States have issued state wide mask mandates.

As ESF-6 lead, City of Columbia Division of Human Services has organized five local funders (City, County, United Way, Community Foundation, and VU Foundation) in a collaborative called ComoHelps (<u>http://comohelps.org</u>). Through this collaborative we have consolidated financial donations for the COVID-19 response. Financial contributions are being routed to the Heart of Missouri United Way and the Community Foundation of Central Missouri. Nonprofit and governmental volunteer needs are posted, along with the opportunity for community members to sign up as unaffiliated volunteers for assignment as needed.

ComoHelps also developed a single, joint application for nonprofits to submit requests for funding. This expedites access to support for nonprofits and allows us to coordinate funding used in response to the COVID-19 pandemic. The ComoHelps collaborative meets daily to review and prioritize requests and to allocate funding. The current focus is on funding services being provided in response to COVID-19. Requests for nonprofit sustainability are being referred to federal CARES Act programs and tabled for later consideration. Because this funding collaborative is so unique, ComoHelps have received grants from state and national foundations.

MU Healthcare hosts a drive thru COVID 19 testing site located at 115 Business Loop 70 W. The site hours of operation to Mon-Fri 8 AM to 7 PM, Saturday 8 AM to Noon, and closed on Sundays.

Boone Hospital hosts a drive thru COVID 19 testing site. This site's hours of operation are Mon-Fri 8 AM-4:30 PM, and Saturdays 8 AM to Noon, closed on Sundays.
