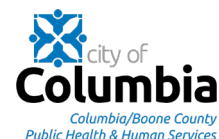

Introduction

Due to the COVID-19 pandemic, the Live Well Boone County annual Community Health Assessment (CHA) addendum was not published in 2020. Updated data in this 2021 CHA addendum relates to the four strategic health issues (Mental Health; Medical/Dental; Safe, Healthy, and Affordable Housing; and Basic Needs) identified in the Community Health Improvement Plan (CHIP).

The most recent data available in this addendum are from 2019 (with the exception of the Point-in-Time Homeless Count, Living Wage Calculation, and Status Report on Missouri's Substance Use and Mental Health), before the pandemic reached Boone County. It is anticipated that secondary data sources reflecting the impact of COVID-19 to be available in 2022.

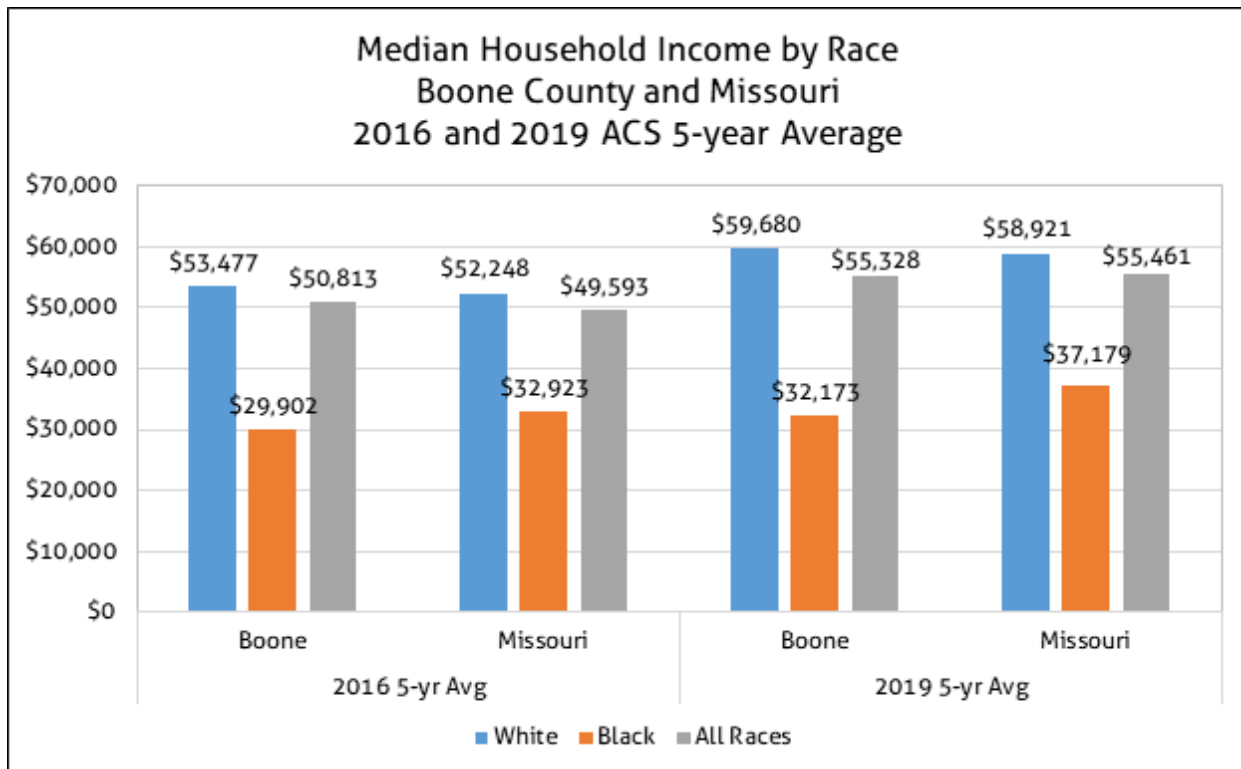

Median household income in Boone County, Missouri, and the United States all increased compared to the 2016 ACS 5-year average.

Black households in Boone County continue to make slightly more than half the median household income of white households. For the 2019 ACS 5-year average, Black households earn about 54 cents for every dollar earned by white households. This is a slight decrease from the 2016 ACS 5-year average when a Black household earned 56 cents for every dollar earned by a white household.

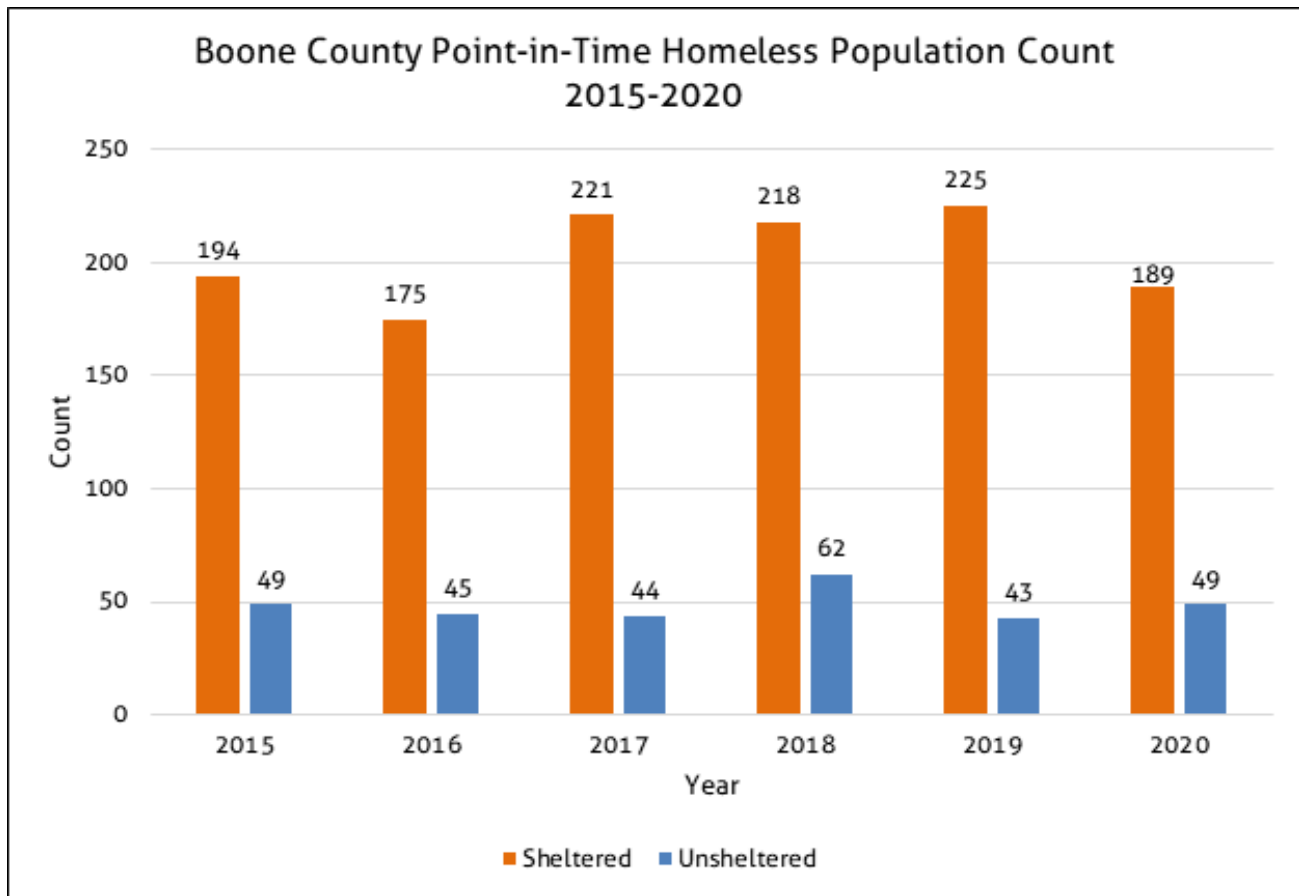

Boone County Chronic Disease Deaths by Race, 2012-2016 and 2015-2019 ACS 5-year Averages

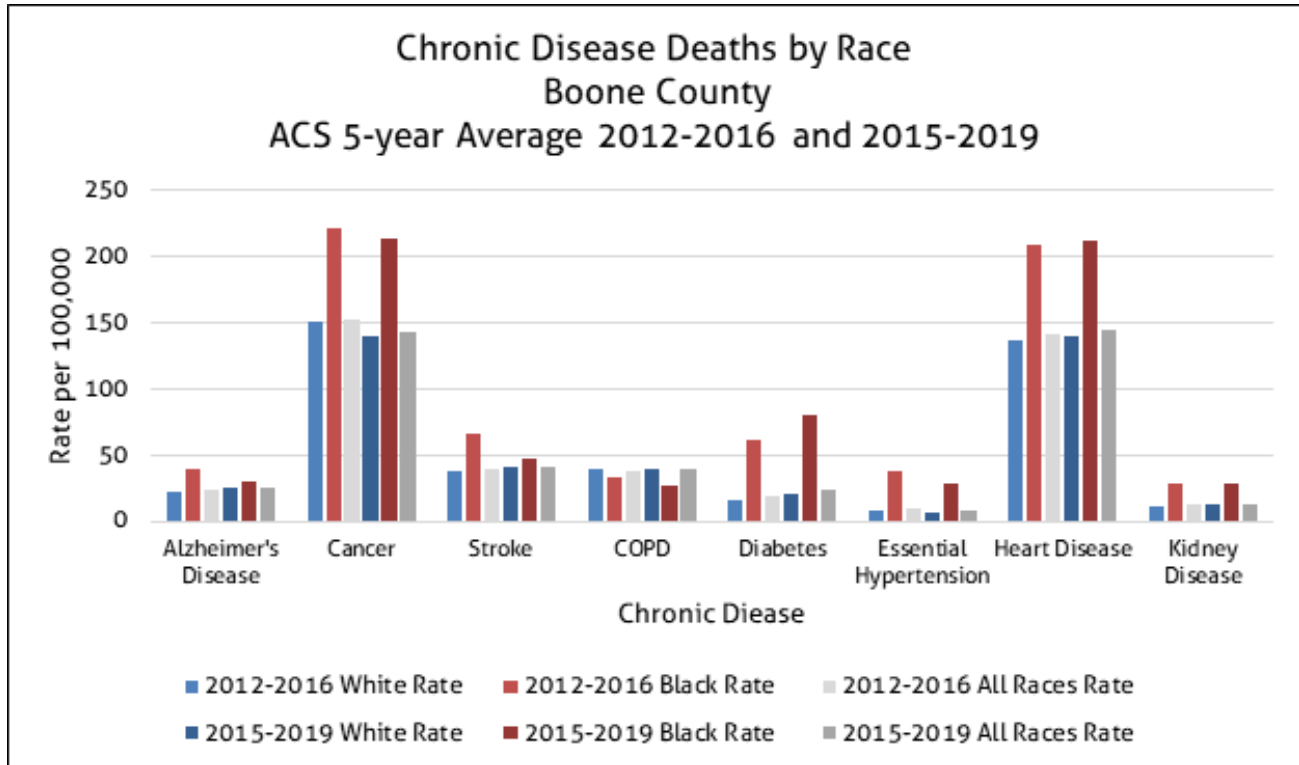

Leading Causes of Death, Boone County and Missouri, 2016-2019 MOPHIMS Death MICA

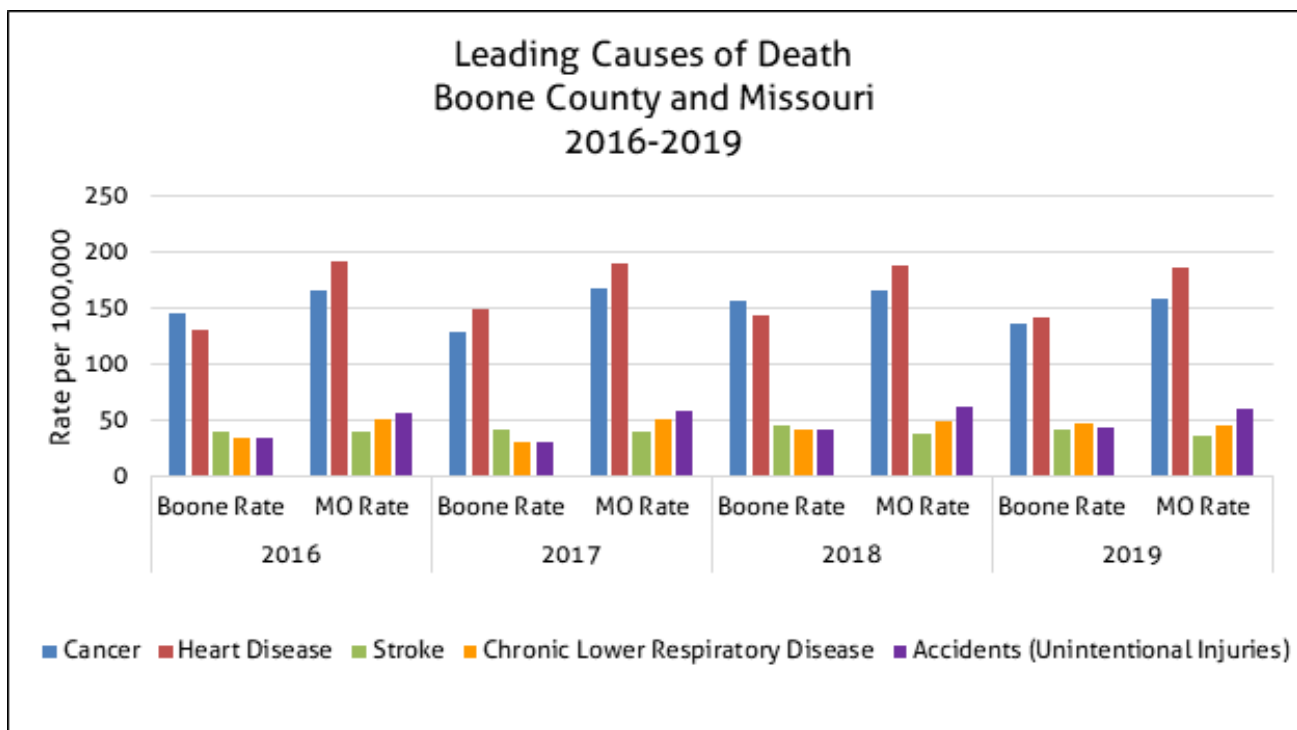

Causes of Death by Sex, Boone County, 2012-2016 and 2015-2019 MOPHIMS Death MICA

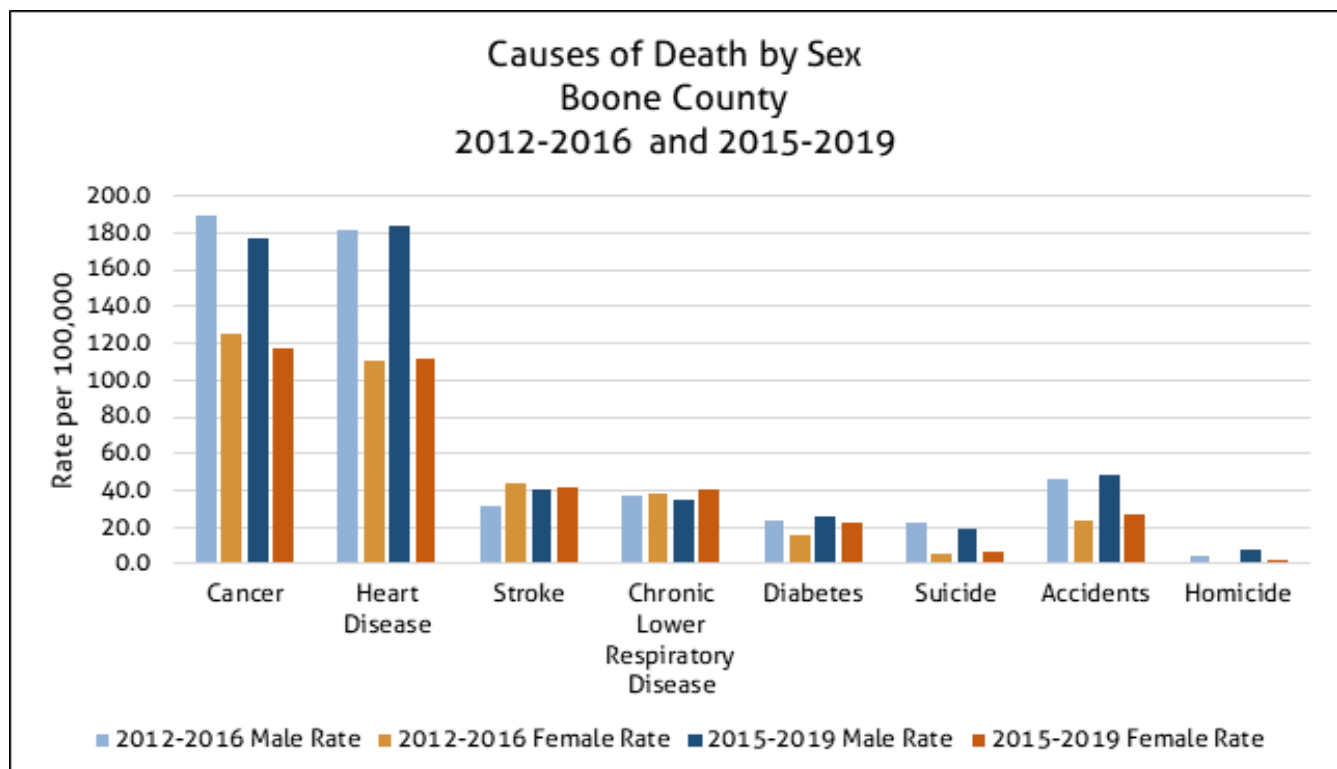

Cancer Death Rate by Race, Boone County, 2007-2008 to 2019 MOPHIMS Death MICA

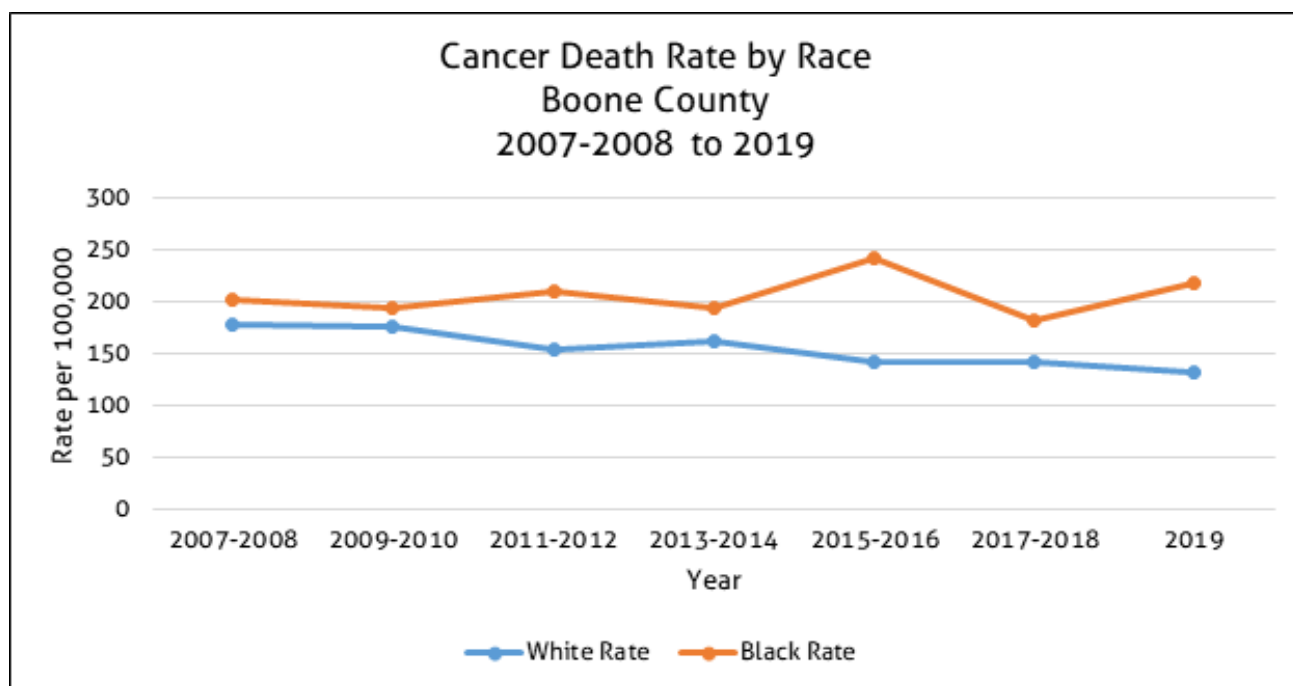
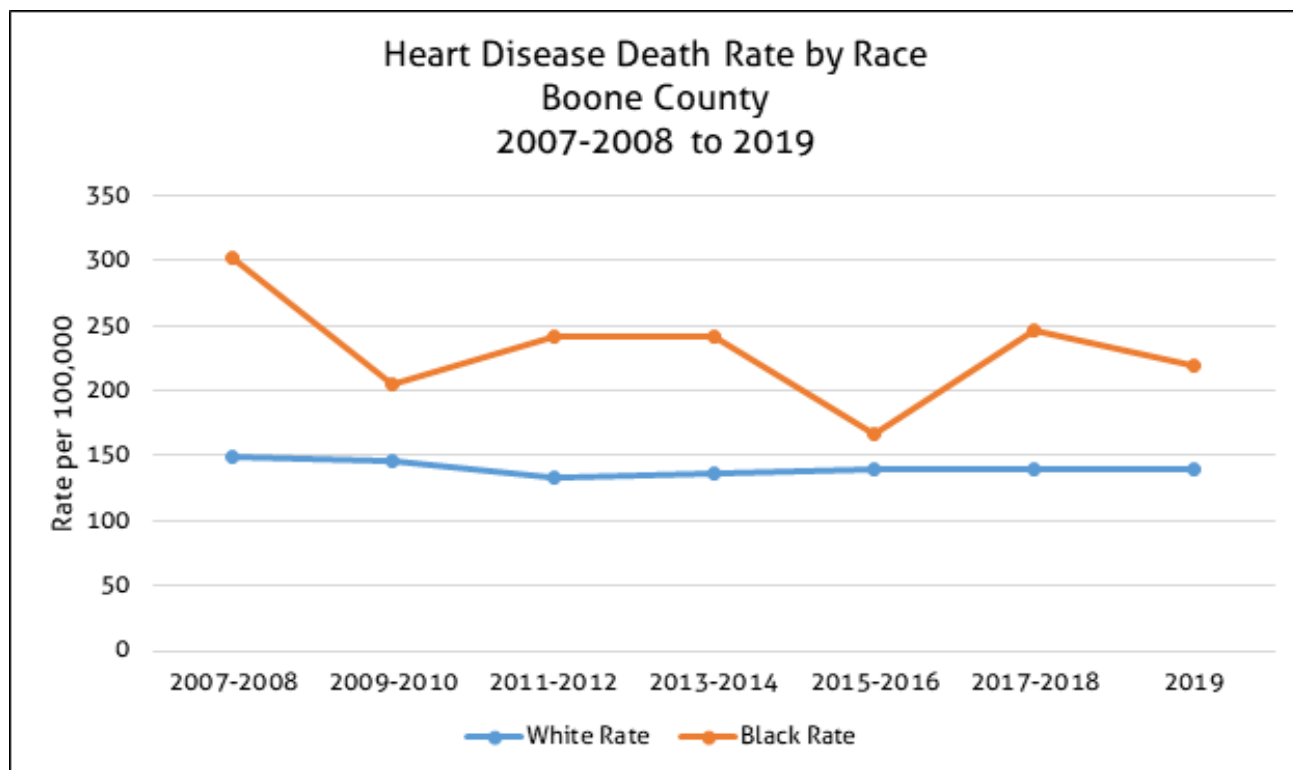
