Notice is hereby given of a public hearing for the consideration of the following documents:

1. Proposed Amendment to the CATSO FY 2022-2025 Transportation Improvement Program (TIP)

2. Proposed Amendment to the CATSO Major Roadway Plan – Sinclair Road area

3. Proposed Amendment to the CATSO Major Roadway Plan – Tradewinds Parkway

The documents will be reviewed at the regular quarterly meeting of the Columbia Area Transportation Study Organization (CATSO) Coordinating Committee, to be held in the City Council Chamber of the Daniel Boone Building, First Floor, 701 East Broadway, Columbia, Missouri, on Thursday, February 24, 2022 at 2:30 p.m.

The public is encouraged to make comments on the proposed amendment to the FY 2022-2025 TIP, which lists transportation projects planned for the CATSO metropolitan planning area, with the focus on projects with federal funding. The amendment includes the addition of one new MoDOT project in the CATSO MPA for lane striping work on Interstate 70.

The public is also encouraged to make comments on the proposed amendments to the Major Roadway Plan (MRP). The MRP is a long-range plan that identifies general alignments and classifications of roads needed to meet long-term transportation needs – it is not a list of construction projects.

The first proposed amendment would remove a number of future potential collector streets currently on the MRP along the Sinclair Road corridor, while adding a new future east-west collector street to extend west from the terminus of Southampton Drive and make a connection to Old Mill Creek Road.

The second proposed amendment would change the classification of the existing and potential future sections of Tradewinds Parkway from Minor Arterial Street to Major Collector Street.
