I further state under oath that no distiller, wholesaler, wine maker, brewer or their employees, officers or agents have any financial interest in the retail business of the applicant for the sale of intoxicating liquor and that such persons will not, either directly or indirectly, loan, give away or furnish equipment, money, credit or property of any kind except ordinary commercial credit for liquor sold to the applicant. I further promise and agree that I will not permit the installation or operation of any unlawful gambling device in or about the premises set forth in the above application.
