Committee Charge

Section 1:

- Seven members, a ward-based member selected by each council person and chair selected by mayor
- Committee established until final report is submitted to Council on Feb. 15, 2022



Committee Charge

Section 2:

 Submitted report should include one or more recommendations for new ward boundaries with documentation of comparative population figures and geographic shifts.



Committee Charge

Section 3:

- The proposed boundaries will adhere to the following principles:
 - Ensure as equal a count of population per ward as possible.
 - The redistricting should serve the needs of existing neighborhoods, neighborhood associations, business districts, and other recognizable demographic features wherever possible.
 - The recommendation for redistricting should ensure wards are as compact and contiguous as possible.
 - Recommendations to ward changes should prioritize balancing population changes between the 2010 and 2020 decennial census and minimize change to existing boundaries.

Committee members to collectively review public input for integration into report to Council.








Trial A (and B) 1st to 2nd w/ neighborhoods




Trial A 1st to 2^{nd w/ blocks}




Trial A (and C) 5^{th to 4th w/} neighborhoods










Trial B 5th and 6th to 4th w/blocks


Trial C 6th to 5th w/ blocks






















