
Not adhering to the Guidelines for Personal Care Facilities.

I, Evan Day, entered Elite Barbershop (3601 Buttonwood Drive, Columbia MO, 65201) at 11 a.m. on Saturday, July 18. Upon entry I witnessed three barbers violating the mask ordinance and public health order by cutting the client's hair and not wearing masks. Several clients were wearing masks, however not all of them, as shown in the photo sent to the City of Columbia. Clients were removing masks before they sat down in the chair to receive their service, but it was unclear if they did so voluntarily or if they were told to by the barbers. The owner, Adam Prosser, was in the establishment at the time of my visit. There was no sign on the door to notify customers of the mask requirement upon entry. There was also no system to keep track of clients, as I was a walk-in customer and was never asked my name or contact information for possible contact tracing if there were to be a positive case/exposure within the establishment. I did not feel comfortable confronting the owner or barbers about why they were not enforcing the mask ordinance because during a previous visit the owner shared his disagreement for how the county was handling the pandemic.
