Did there and then commit the following offense and the facts supporting this belief are as follows:

The City of Columbia received a citizen complaint about mask order violations at this business. It was received on July, 22, 2020.

I visited the store on Thursday, July 23, 2020 at approximately 12:30pm and made the following notes:

I PERFORMED AN ON SITE VISIT THIS AFTERNOON. I OBSERVED THE BUSINESS FOR OVER 10 MINUTES WHILE IN MY WORK JEEP. WITHIN THAT TIMEFRAME I WATCHED CUSTOMERS COME IN WITHOUT MASKS AS WELL AS WORKERS WORKING WITHOUT MASKS. MASKS WERE IN THEIR POCKET BUT THEY WERE NOT WEARING THEM. SARAH WAS MOVING AROUND SEVERAL CUSTOMERS WITHIN 1 FOOT AND DID NOT HAVE HER MASK ON. I OBSERVED A WORKER WHOSE NAME TAG I COULD NOT SEE CARRYING A PIZZA TRAY BACK TO THE KITCHEN WITHOUT WEARING A MASK AS WELL AS AN EMPLOYEE NAMED DEE WHO WAS WORKING AS CASHIER WITH HER MASK NOT FULLY COVERING HER MOUTH AND NOSE. AFTER IDENTIFYING MYSELF, I ASKED DEE IF I COULD SPEAK WITH THE MANAGER. SARAH CAME OVER, NOT WEARING A MASK AS SHE APPROACHED AND TOLD ME THAT THAT SHE WAS THE LEAD SALES ASSOCIATE. I ASKED IF THEY WERE AWARE OF THE MASK ORDINANCE. SHE THEN GOT HER STORE MANAGER, TRACY. TRACY APPROACHED ME ANGRILY, NOT WEARING HER MASK APPROPRIATELY. I ASKED IF SHE WOULD PLEASE MIND RAISING UP HER MASK AND SHE REFUSED. I TRIED TO BACK AWAY AND SHE MOVED FORWARD AGAIN TOWARDS ME. I ASKED IF THEY NEEDED INFORMATION ABOUT THE ORDINANCE

AND SHE SAID THAT THEY HAD A SIGN UP. I OBSERVED THE SIGN ON THE FRONT DOOR HAD VERY SMALL WORDING UNABLE TO BE READ WITHOUT GETTING VERY CLOSE TO THE DOOR. SHE ALSO STATED THAT THEY WERE TOLD BY THEIR REGIONAL MANAGER TO IGNORE THE MASK VIOLATION AND THAT THEY WERE TOLD CUSTOMERS COULD COME IN AND OUT WITHOUT MASKS BECAUSE THEY COULDN'T ASK THEM TO PLACE ON A MASK. SHE STARTED TO ESCALATE HER VOICE AND TOLD ME THAT I NEEDED TO CONTACT THE REGIONAL MANAGER. SHE REFUSED TO GIVE ME THEIR CONTACT INFORMATION BUT RATHER GAVE ME THE STORE NUMBER I ALREADY HAVE. I ADVISED THAT I WAS HOPING TO PROVIDE EDUCATION BUT SHE INDICATED SHE WAS NOT INTERESTED AND THAT SHE REITERATED THAT SHE HAD INSTRUCTIONS FROM SOMEONE ELSE TO IGNORE THE ORDER. I TRIED TO TAKE PHOTOS BUT THAT WAS IMPOSSIBLE WITHOUT PUTTING MYSELF IN POTENTIAL HARMS WAY. I WAS ABLE TO GET A PHOTO FROM OUTSIDE OF SARAH WORKING WITHIN 1 FEET OF CUSTOMERS AND NOT WEARING A MASK. I AM FORWARDING THIS CASE TO THE CITY OF COLUMBIA PROSECUTING ATTORNEY FOR FURTHER ACTION DUE TO THE BLATANT VIOLATION OF THE MASK ORDINANCE.

That these facts herein are true and constitute a violation of Emergency Ordinance 024284, Section 4 of the Columbia Code of Ordinances and punishable under Ordinance 024284 Section 9 of the Columbia Code of Ordinances.

In each of these visits, there have been multiple employees not wearing masks among the what seems to be more than half of customers consistently refusing to wear masks, and the store not enforcing the ordinance. Today, 7/21, there were 4 visible employees in the store, two of which were not wearing masks, and one of those two being the store manager! This blatant disregard for public health is appalling, and should warrant disciplinary action."
